- A celebration of mothers will be held on May 26, 2017 at Thornwood from 5:00 8:00 p.m. sponsored by the Hispanic Outreach Leadership Association.
- The Student Board election was held and the results are in for the next school year.
- Brett Fickes, Director of Curriculum and Instruction, is a recipient of the Josephine Elizabeth Seaton Franklin Foundation Vision Quest Award which will be presented to him on May 20, 2017.
- Thornridge Jazz Band received a superior rating (39.5 out of 40) and the Concert Band received a superior rating (49.6 out of 50) at the IHSA State Organizational.
- Thornridge presented scholarships at its 3rd Annual AVID Awards Banquet.
- The Wildcat Olympic Team won 9 gold medals, 4 bronze medals and 8 athletes qualified for state competition.
- Thornton Advisory Council hosted an Old School vs. New School basketball game.
 The final score was New School: 84, Old School 81.
- Thornton IB students David Clay received a \$68,000 per year scholarship to Vanderbilt University and Maribel Salgado received a \$69,000 per year scholarship to Wesleyan University.
- Special Olympic athletes competed in the Area 7 Track and Field meet on May 6, 2017 at Richards High School. First place athletes will advance to the State Track and Field meet at ISU on June 9-11, 2017.
- Thornwood Engineering Robotics team won 2nd place at the Southworks Robitics Olympics hosted by the South Suburban Mayors and Managers Association and the Chicago Southland EDC.
- Mr. Michael Blair, co-founder of A Few Good Men, and Thornwood student members spoke of the benefits of this male mentoring program which began in 2011 with 17 young men and today consists of 175 graduates and current students. The mission of A Few Good Men is to teach, build confidence and mold young men to become responsible adults, focusing on brotherhood, scholarship and service learning. A Few Good Men student members have the highest GPA's and best attendance of any student activity group in the district. The Board provided them with medals for all their efforts.

Mr. Dwayne Bearden, Faculty Association President, stated that as he presented at the September Board meeting, the four key elements that will move the district forward are collaboration, communication, transparency and respect. Unfortunately, these have not been met, i.e., the implementation of SB100, creation of PEACE Center, Outlook Academy, Division Leaders and district finances. Instead of the administration working with the association, the president and executive director have been reprimanded. This does not help meet the needs of our students. The association still desires to work with the Superintendent, Board and administration to move the district in the right direction, but their rights as an association must be respected.

The funding source is capital bonds. In response to the Board, Mr. Garrett stated the renovations are for approximately 26 bathrooms at Thornwood and domestic water mains at Thornton. Phase 2 will occur next year and includes upgrades and renovations at Thornridge and Thornton as well as domestic main upgrades at Thornridge.
