Jennifer Lavigne, Faculty Association Representative, arrived at the meeting late due to weather conditions and presented the Ray Price Memorial Scholarship to three graduates who will enter college to become teachers. They are: Tawana Brown from Thornridge; Shifa Vhora from Thornton and a Student Board Member and De'ja William from Thornwood. All three graduates aspire to become math teachers. The Board congratulated the recipients.

Mr. Thomas presented a review of the 2012-2013 school year. Some of the highlighted District-wide results are:

Attendance is 91.2%; graduation rate is 69%; mobility rate is 17.4%; dropout rate is 2.1%. The suspension rate has decreased by 29%. The declining enrollment is an issue that needs to be addressed. Forty-three percent of freshmen entered below grade level and the District has not made AYP. Of significance is the fact that just recently Thornton School District 154 requested a detachment from District 205 to send their high school students to Homewood Flossmoor District 233. If granted, District 205 will lose \$2.9 million in tax revenue. Mr. Thomas will visit to District 154 to address the issue.

Mr. Thomas reviewed the EPAS, Explore and Preliminary ACT scores. It appears that the composite for the ACT will be 17, which it has not been in 8 years. He reviewed the strategic plan to accomplish the District goals. There are approximately 25 strategies for each of the four goals. He explained the seven District Focus categories which are: instruction; instruction delivery; instructional assessment; remediation and accelerated learning; professional development for teacher continuous improvement, leadership and resources to support implementation. All departments have developed missions and strategies to meet the goals aligned with the Board goals.

Accomplishments of the Curriculum department include the Joint Institute Day with the feeder schools; implementation of the evaluation cycle; total revision of the Curriculum handbook; new programs with South Suburban College and Chicago State University; parent and community academy, Latino awareness committee and others. Innovative programs include AVID (Advancement Via Individual Determination) and College and Career Pathways.

Other topics were focus walk-throughs for the Student Board; parent community training, keeping up with technology (online registration) and Professional Development for staff and administration. The Google Chrome Book is an initiative for incoming freshman which would eliminate textbooks. Online research can be done for Career Cruising to allow students to do research to plan for college and careers. The Public Relations Department has created a bill board to garner the thought process for students to enter District 205 schools.

Mr. Thomas gave a summary of the financial picture of the District and responded to questions from the Board. General State Aid and transportation funding will decrease. The declining enrollment and real estate taxes affect the future revenues dramatically.

At 7:40 p.m., Mr. Robinson moved, Mrs. Williams seconded to go into **Executive Session** E for the purpose of discussing student discipline, employment, compensation discipline or S dismissal of specific employees and personnel.
