The following individuals spoke during Public Participation:

PUBLIC PARTICIPATION

- Felita Crayton (Dolton) asked if there was a committee assigned to put the parent resource page on the website. Dr. Buckner responded that based on the last Board meeting, it became clear that the community wanted more information. The Principals took information to their community groups. Dr. Buckner asked parents for guidance as to what information they wanted on the webpage. Each Building's parent advisory will continue to build on the webpage. Some of the information is provided by the federal website for Board policy.
- Gail Frazier (Dolton) stated that Power School is useful and asked if it was true that Mrs. Crayton is no longer the parent coordinator for Thornridge. Dr. Buckner stated she would speak to Mrs. Frazier personally after the Board meeting.

Mr. Gress stated that the 2009-2010 snow removal contract was awarded to Four Seasons and that pricing on snow removal equipment is being obtained for the 2010-2011 school year so that snow removal services can be done in-house. More detailed information will be forthcoming.

SNOW REMOVAL BID UPDATE

Mr. Williams moved, Mr. Burton seconded, to **Approve the 2009 Tax Levy** as presented by Mr. Gress in the amount of \$59,836,513. The tax levy was presented at the November Board meeting and there have been no changes and no inquiries on the levy presented. The Finance Committee recommends approval of the Tax Levy and the Resolution to Apportion the Tax Levy. The resolution instructs the County Clerk how to reduce the tax levy should the District receive less than a 4.99% increase. On roll call, Members Banks, Burton, King, Lawrence, Penman and Williams voted aye; nay, none; motion passed.

APPROVAL OF 2009 TAX LEVY

Mr. Shields reported on the public interest results of the vaccination program offered through the Cook County Department of Public Health. Four confirmed cases of the H1N1 virus have been reported district-wide; there were less than five requests for the vaccination; absence rates are normal for this time of year, and a neighboring high school district held a clinic and only had 200-300 students sign up for the vaccination. The nurse's opinion is that the benefit does not justify disruptions in the classrooms and nurses are providing information for any interested parents. Mrs. Lawrence encouraged everyone to follow the Emergency Influenza—Like Illnesses (ILI) Intervention Plan implemented by District 205 which helps keep students and staff from getting sick. Mr. Burton suggested the District speak to health advocates in order to be pro-active and watch for a spike in the virus. Mr. Shields will investigate as to how many feeder schools were involved in the program. Dr. King asked Mr. Shields to make a recommendation to the Board.

Mr. Ratliff presented on the Climate and Culture of the Freshmen Academy of all three schools. In order to support the Freshman Academy program to help students master the skills necessary for a regular high school curriculum, 1) a bridge must be built between the high school and the feeder schools by establishing strong relationships with feeder schools principals, speaking to 8<sup>th</sup> grade students and obtaining data to determine what District 205 needs to offer them as freshmen. The high school will have a strong freshman team of directors, counselors and deans to provide activities, athletics, career adventures and discipline expectations to the students. 2) Middle school students will be brought into the high school on field trips to observe career programs, including but not limited to culinary arts and Navistar, that will be available to them as high school students.

BOARD GOALS II, CLIMATE AND CULTURE PRESENTATION

Discipline issues have decreased significantly at Thornton. Communications with parents, attendance at Parent Night and extra-curricular opportunities for students have increased.

Mr. Savage reported on the Discipline Committee and its mission. The Committee structure is based on the Illinois School Discipline Code and the District 205 Board of Education Policy.
