Your name will not be called if you do no sign in and list a topic or the topic is not on the current Board agenda or if public participation has begun.





## **Cafeteria Committee Presentation**

<u>Chair</u>: Sonja Bradley <u>Committee Members</u>: Mario Carr,Christyana Arrington, Desha Holloway, Nate Edwards and Jada Thomas Cafeteria Committee's Mission Statement The Cafeteria Committee is one of nine committees of the Student Board of Education. The committee functions as an investigator of the operations and quality of the District 205 food service program. The committee's charge is to focus on: food quality, food preparation, and the cleanliness of the cafeteria.

The members of the Cafeteria Committee are Christyana Arrington (Thornton), Mario Carr (Thornridge), Jada Thomas (Thornwood), Nate Edwards (Thornwood), and Desha Holloway (Thornwood). The chairperson for the Cafeteria Committee is Sonja Bradley (Thornridge). The Committee must conduct research to create a cleaner and more satisfying cafeteria.

## Background Information

Over the last 6 months, the cafeteria committee has implemented a three-phase plan to gather input and information regarding the operations and quality of the food services in District 205.

Phase one was to gather quantitative data. Quantitative data is numerical information, therefore the committee conducted an online survey for students to take during their lunch periods. Five hundred fifty students completed the online survey that measured several aspects of the cafeteria.

Phase two was to gather qualitative data. Qualitative data consists of words and narratives. We gathered this data by hosting three cafeteria reform circles, one at each of the District 205 schools. Students had a chance to express their thoughts, ideas, and concerns regarding the cafeteria environment. Fifty students from all three schools engaged in our cafeteria reform circle.

Our last phase was to present our findings and conclusion to our constituents and the Senior Board of Education. During this phase, the cafeteria committee will be distributing and presenting our findings to Sodexo, administration, building staff and, Board of Education.

While about 7% percent of students see the food as high quality, the majority of students would rate it low to very low quality.

Recommendations

\*Below are recommendations that the committee developed based on the data to possibly improve the cafeteria experience for students.

- Develop a rotating menu of high quality entree and a la carte options.
- **♦** Offer more options for condiments.
- **Research options to decrease the price of snack items.**
- Increase the quality of the food that is served in the cafeteria.
- More training for cafeteria staff focused on improving customer service and presentation.
- Improve plates and cutlery used in the cafeteria.
- Develop a quality control reporting system with the cafeteria committee to keep open communication with cafeteria management regarding students' needs and concerns.

### **Key Components to Driver's Education Range**

- Students drive to instructions given by an instructor who is in an observation tower or on the range and communicates through the vehicle's radio.
- Our range is designed in such a manner as to provide experiences which allow students to develop and exercise the human functions of <u>perception</u>, <u>judgment</u>, and <u>decision-making</u>.
- One or two vehicles will be mastering some type of maneuver while the rest would be meeting each other in situations similar to on-street experiences.
  - Specific objectives of a range designed with this principle in mind are to enhance the visual search patterns, judgment and decision-making abilities of beginning drivers. Lessons can be structured in such a manner so that beginning driver is required to more critically observe and analyze traffic flow thereby enabling to merge and/or blend with flow of traffic on the facility under conditions very comparable to real world driving.

Research and study have shown that actions a driver takes are based directly upon his/her decision-making abilities. These decisions can only be as good as the information upon which they are based. Adequate visual perception and proper judgments of time and space form the basis upon which sound decisions are made while driving.


