

Breakdown of Budgeted Revenues by Source





Excluding Major Construction Expenses



Financial Threats Facing District

- Shifting of teacher pension costs from State to District.
 - Estimated Impact: \$1.7 million per year
- State changing transportation reimbursement formula.
 - Estimated Impact: \$1.1 million annually.
- Creation of charter school.
 - Estimated Impact: Loss of Revenues of \$2.2 million in FY 2015, \$4.3 million in FY 2016, \$6.2 million in FY 2017 and \$7.9 million annually thereafter.
