Nepotism Policy

Current Policy

The Board of Education shall not hire any individual for a full-time position if the individual is a member of the immediate family (parents, spouse, or child) of a District 205 Board member or an administrator.

Recommendation

Suspend the policy

Rationale:

- Suggests that there is something inherently wrong with immediate family members (but not with other family members)
- Board Members have no hiring authority in day-to-day personnel.
 Therefore no ability to pick a family member
- Deters family members of the Board from pursuing a career in education/ committing to their community
- The district has a rigorous hiring process in which all candidates must pass



 Presentation of Student Athlete Concussions and Head Injuries Policy (Policy Section 7:305) –
 Dr. Lyke

Student Athlete Concussions and Head Injuries

Recommended Policy

The Superintendent or designee shall develop and implement a program to manage concussions and head injuries suffered by student athletes.

- A student athlete who exhibits signs, symptoms, or behaviors consistent with a concussion in a practice or game shall be **removed from participation** or competition at that time.
- -A student athlete who has been removed from an interscholastic contest for a possible concussion or head injury may not return to that contest unless cleared to do so by a physician licensed to practice medicine in all its branches in Illinois or a certified athletic trainer.
- If not cleared to return to that contest, a student athlete may not return to play or practice until the student athlete has provided his or her school with written clearance from a physician licensed to practice medicine in all its branches in Illinois or a certified athletic trainer working in conjunction with a physician licensed to practice medicine in all its branches in Illinois.

Student Athlete Concussions and Head Injuries

- Inform student athletes and their parents/guardians about this policy in the Agreement to Participate or other written instrument that a student athlete and his or her parent/guardian must sign before the student is allowed to participate in a practice or interscholastic competition.
- 3. Provide coaches and student athletes and their parents/guardians with educational materials from the Illinois High School Association regarding the nature and risk of concussions and head injuries, including the risks inherent in continuing to play after a concussion or head injury.
- Include a requirement for staff members to notify the parent/ guardian of a student who exhibits symptoms consistent with that of a concussion.

Algebra 1 Restart Program

- Data to support a change in current practices:
 - 31% of all D205 Geometry students are short one math credit
 - These students account for 53% of Q1 F's in Geometry
 - 38% of all D205 Algebra II students are short math credit
 - These students account for 72% of Q1 F's in Algebra II
 - "The single highest failure rate in high school is Algebra I.
 After pregnancy, it's the leading indicator of high school dropout."

Algebra 1 Restart Program

Past Practice


- Fall 2011: Student fails Algebra1 Semester 1
- Spring 2012: Student continues on to Algebra 1- Semester 2
- Summer 2012: Student may retake Algebra I
- Fall/Spring 2012: Student takes
 Geometry or Geometry with
 Support for Sophomore year
 - Students still short on algebra credit almost twice as likely to fail Q1 as those students with 1 full algebra credit

New Practice

- Fall 2011: Student fails Algebra I-Semester 1
- Spring 2012: Student <u>retakes</u>Algebra 1-Semester1
- Summer 2012: Student may retake any other failed course or take an elective course
- Fall/Spring 2012: Student takes
 Hybrid Algebra 1 Semester 2 and
 Geometry course for two periods all
 year

FRESHMAN YEAR

1st Semester

Health Education

- All freshman students will take 18 weeks of health (*in either the first or second* <u>semester</u>).
- Topics covered will include: Diseases, Drugs, Mental Health, Nutrition, Personal Health, and Sexuality.

2nd Semester

- Physical Education
 - All freshman students will take 18 weeks of physical education (*in either the first or second semester*).
 - Units covered will include: Swimming (9wks), Conflict Resolution Training (4.5 wks), and Introduction to Fitness (4.5wks)

SOPHOMORE YEAR (OPTION 1)

- o 1st Semester − 18 Weeks of Driver Education
 - Classroom, 30 hours of simulation training and 3 hours of Behind The Wheel training (BTW)



SOPHOMORE YEAR (OPTION 1 CONTINUED)

- o 9 weeks of swimming/lifeguard training
- 9 weeks of PE II
 - PE II consists of students being allowed to choose their activity on a daily basis (health club) based upon gaining lifetime fitness. Options include:
 - oRunning/Track
 - oBikes
 - oJump rope



SOPHOMORE YEAR (OPTION 2)

- Student takes PE II for 2 semesters, no driver education
 - 9 weeks of swimming/lifeguard training
 - 27 weeks of PE II. PE is done in a "health club" setting.
 - •Students can choose their activity on a daily basis. Choices are based upon gaining lifetime fitness. Options could include:
 - Circuit Training
 - o4 on 4 ½ court Basketball
 - Railyard



JUNIOR YEAR

• All junior students take PE III. In this course the students are allowed to choose their activity in a "health club" setting. Activities are based upon gaining lifetime fitness skills.

Options could include:

- Team Sports
- o Cardio (Aerobics, DDR, Wii)
- Volleyball



SENIOR YEAR

• All senior students take PE IV. In this course the students are allowed to choose their activity in a "health club" setting. Activities are based upon gaining lifetime fitness skills.

Options could include:

- Railyard/Fitness Trail
- Basketball Drills
- Badminton



CONDITIONING CLASS (ELECTIVE)

- An 18 week (<u>one semester</u>) or 36 week (<u>year long</u>) class that is for IHSA athletes. Students in this class should be at least a sophomore in school and on a school team that competes in the IHSA. Coaches approval is needed to be placed in this class.
- Students will lift weights, complete fitness/ strength tests, and work on cardiovascular conditioning as well. Students either work on "in-season" workouts or "off-season" workouts.

Adapted Physical Education


• A 36 week (<u>year long course</u>) that is for our students with special needs. These students work on attaining lifetime fitness goals just as the regular education students.

Activities could include:

• Shuffle board, aerobics, bikes, track, floor hockey, circuit training, water safety skills, Wii games.






