# **COPY PAPER BID**



- On March 21 Thornton Township High School District 205 held a bid opening for copy paper for the FY12 school year.
- Five bids were received. Option one was to deliver all the paper in one delivery. Option two was to have quarterly deliveries to prevent damage or loss from storing it in the warehouse.
- The low bid was submitted by RIS Paper in the amount of \$80,512 for one delivery and \$82,304 for multiple delivery dates.

# PE UNIFORM BID



- On March 21 Thornton Township High School District 205 held a bid opening for PE uniforms for the 2011-2012 school year.
- \* Three bids were received and the low bid was submitted by St. John Sports in the amount of \$35,329.90.
- St. John Sports has been the provider for the past several years.
- \* A sample uniform was reviewed by the physical education area instructional leader and was found to be in compliance with specifications.
- The Finance Committee is recommending awarding the bid to St. John Sports.

### SUMMER ASBESTOS REMOVAL BID




- This bid is for asbestos removal that is necessary prior to the installation of the new windows at Thornton. It pertains only to the windows that contain asbestos.
- Seven bids were received. AMW is the low bidder in the amount of \$266,000

# **HVAC PRE-PURCHASE BID**



- Six bids were received on April 6 for the 2011 HVAC Pre-purchase of equipment.
- \* TRIA Architecture is recommending Bid Package "A" be awarded to Thermosystems, Inc. in the amount of \$784,500; Bid Package "B" be awarded to Temperature Equipment Corporation in the amount of \$37,740; and Bid Package "C" be awarded to Midwest Applied Solutions, Inc. in the amount of \$119,670.
- \* All three bidders were the lowest responsible bidder meeting all bid specifications.
- \* The Finance Committee recommends tabling this bid until the new Board is seated.
