# Public Participation

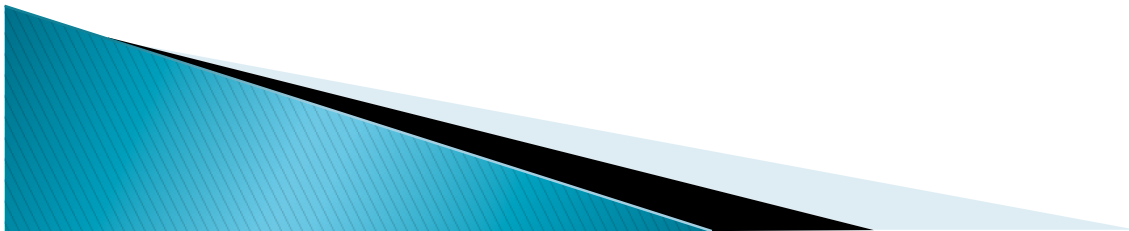
- ▶ We now open the Public Participation section of our agenda. At this time, members of the community are invited to address the Board.

# Capital Improvement Recommendation

On Tuesday, October 5<sup>th</sup> the finance committee met to discuss the possibility of capital improvement expenditures on heat and air conditioning for Thornton High School. During that meeting Mr. O'Higgins from Metro Engineering explained that a condenser could be added to a two pipe heating and air conditioning system that would allow for a one day turnaround of the system from heat to air.

There are four options available for this project:

- Heat Only - \$15,148,646
- Heat and Air Conditioning (Two Pipe System) - \$18,350,086
- Heat and Air Conditioning (Two Pipe System) with condensing unit - \$18,800,086
- Heat and Air Conditioning (Four Pipe System) - \$21,879,436

## Capital Improvement (Cont.)

One finance committee member is in support of the two pipe heat and air conditioning system with a condenser at the cost of \$18,800,086. This option is being recommended for board approval.
