

### Video Surveillance Policy

### The proposed policy was:

- Sent to all staff requesting feedback
- Posted on the website with a link to my email to provide feedback
- Discussed at the Parent Advisory Meetings at all three schools

### Video Surveillance Policy

Video cameras may be used in school buildings and on school buses as necessary to maintain the health, safety and welfare of students, staff, visitors and school property, and as a deterrent to inappropriate behavior. The cameras will record activities only in public areas of the school, such as the hallways, stairwells, the gymnasium, cafeteria, school buses, and exterior locations of school buildings. Video cameras will not be used for general surveillance purposes in washrooms, gymnasium or swimming pool locker rooms, changing areas, or showers.

The content of video recordings may become a part of a student's educational record and may be produced as evidence in student administrative discipline conferences and hearings or other proceedings, subject to district policy and procedure concerning student records. Release, maintenance, and retention of any information contained on the videotapes shall be in conformance with the Illinois School Student Records Act and the Federal Education Right to Privacy Act. Where appropriate, the video tape may be shared with law enforcement officials.

Additionally, the content of video recordings may become a part of a teacher's personnel record and may be produced as evidence in teacher discipline conferences and hearings or other proceedings. However, such video recordings shall not be used to evaluate the performance of a teacher's pedagogical duties. Where appropriate, the video tape may be shared with law enforcement officials.

The Superintendent shall develop procedures for the use of video cameras. Such procedures shall address how long recordings shall be kept, where the videos will be stored and how they will be erased.

### PROGRAM MISSION & VISION



It is the mission of The Capital Improvement Committee to work with student organizations, members of the District 205 school community and administration to provide the means and support for planning, evaluating, and financing capital planning in District 205. The renovation and possible building of infrastructure and the capital assets of the District are of vital importance to the delivery of quality services to all students.

### PROGRAM GOALS

- 1. To gain student input regarding capital improvements in District 205.
- 2. To provide an open forum for District 205 students to participate in the capital improvement process.
- 5. To provide capital improvement recommendations that will provide a more functional educational environment for District 205 student.
- 6. To establish relationships with student organizations to be included in the capital improvement planning process.
- 7. To promote visibility, transparency, and inclusiveness in the capital improvement planning process.
- 8. To research, evaluate and present recommendations to both the Student Board of Education and District 205 Board of Education to move forward in the capital improvement planning process.

### PUBLIC HEARING PROCESS

To gain substantive input from the Thornton Township High School District 205 student body regarding the general sentiment of what capital improvement in District 205 should look like, the Capital Improvement Committee held three public hearings during the months of November and December. The committee invited the leadership from various student organizations at each school to testify and answer the following essential questions:

- 1. What does the ideal school look like in terms of classrooms, cafeteria, recreation, fine arts/drama and athletics? (**Dr. Carl E. King, Sr.**)
- 2. Should the District build three new schools or renovate current facilities (please provide reasons to support either position)?
- 3. What would technology look like in the perfect school?

### Background

- 16 student organizations testified.
- 50 students represented all three buildings.
- The Capital Improvement Committee met for over three months after school to plan and implement the process.
- Hearings were held at all three schools.
- Committee members visited Thornton Fractional North High School.

### RECOMMENDATIONS

Per the direction of the District 205 Board of Education and based on input from the Thornton Township High School District 205 student body, The Capital Improvement Committee makes the following recommendations to The Student Board of Education:

## Energy & Mechanical Contract

- The last energy and mechanical contract was for services beginning with the 2007-2008 school year.
- A three year contract was awarded. The Illinois School Code does not require bidding out energy and mechanical contracts.
- Two options for renewal were presented:
  - One year renewal with no increase
  - Three year proposal with no increase in the first year, and 3% increases in years two and three.
- The Finance Committee reviewed the proposal and asked that Precision consider lowering the increase for years two and three in the second option to 1.5%.
- Precision has requested that the increase for years two and three be at 2%.

 Recommended Approval of Transportation Services Contract Renewal (Policy Section 2.34)

### Transportation Services Contract

- The last bid for the bus contract was for services beginning with the 2006-07 school year.
- A three year contract was awarded with the option to renew for up to two years.
- This is the last of the possible renewal years.
- Cook Illinois has proposed a 1.6% increase for the 2010-11 school year. They have stated that this increase is to cover the salary increase for their union drivers.
- The Finance Committee is recommending Board approval of the one year extension with Cook Illinois for a 1.6% increase.

 Recommended Approval of RJB Custodial Services Contract Renewal (Policy Section 2.34)

## RJB Custodial Service Contract

- This is also the last possible year to renew the custodial service contract.
- RJB Services has proposed a 2% increase from the 2009-10 rates. They have stated that the entire increase will be passed along as an increase to staff wages.
- The Finance Committee is recommending Board approval of the one year extension with RJB at a 2% increase, but contingent on seeing support that the 2% increase is in fact passed onto the staff.
