

Race to the Top

Preliminary Overview

Four Fundamental Areas of Reform

- Adopting standards and assessments that prepare students to succeed in college and the workplace and to compete in the global economy;
- **Building data systems** that measure student growth and success, and inform teachers and principals about how they can improve instruction;
- Recruiting, developing, rewarding, and retaining effective teachers and principals, especially where they are needed most; and
- Turning around our lowest-achieving schools

Standards and Assessments, cont.

- Develop Science, Technology, Engineering and Math (STEM)-Related Programs of Study
 - Specifically for High Schools
 - Develop Programs of Study course sequences (Completer Sequences)
 - Strengthen academic integration within Programs of Study (UbD)
 - Professional Development for Teachers
 - Real-world connections with mentors in the field (Senior Project)
 - Education and Career Guidance Systems
 - Partnerships with Postsecondary Education (SSC, UIC, Northwestern, others)

Data Systems to Support Instruction

Use of Surveillance Video Policy

- •Video cameras in buildings and buses
- Policy states we will use if for health and safety of our students staff and visitors and a deterrent
- •We will use video only in public areas of the building
- Delineates who has authority/control over the video

POLICY

Use of Video Surveillance

Video cameras may be used in school buildings and on school buses as necessary to maintain the health, safety and welfare of students, staff, visitors and school property, and as a deterrent to inappropriate behavior. The cameras will record activities only in public areas of the school, such as the hallways, stairwells, the gymnasium, cafeteria, school buses, and exterior locations of school buildings. Video cameras will not be used for general surveillance purposes in washrooms, gymnasium or swimming pool locker rooms, changing areas, or showers.

The content of video recordings may become a part of a student's educational record and may be produced as evidence in student administrative discipline conferences and hearings or other proceedings, subject to district policy and procedure concerning student records. Release, maintenance, and retention of any information contained on the videotapes shall be in conformance with the Illinois School Student Records Act and the Federal Education Right to Privacy Act. Where appropriate, the video tape may be shared with law enforcement officials.

Additionally, the content of video recordings may become a part of a teacher's personnel record and may be produced as evidence in teacher discipline conferences and hearings or other proceedings. However, such video recordings shall not be used to evaluate the performance of a teacher's pedagogical duties. Where appropriate, the video tape may be shared with law enforcement officials.

The Superintendent shall develop procedures for the use of video cameras. Such procedures shall address how long recordings shall be kept, where the videos will be stored and how they will be erased.
