

Thornton Township High School District 205 - ARP/ESSER III Spending Plan (2021-2024) Expended by 9/30/2024

ARP/ESSER Allocation Plan \$22,001,447

ESSER III General Allocation = \$21,445,275 (20% must address learning loss)

Proposed Expenditures (80% of allocation = \$17,156,220)

- Replace leaking black roof on damaged sections of school buildings
- Replace/repair (HVAC) heating, ventilation, and air conditioning unit(s) in three (3) buildings.
- Stipends and benefits for administrative assistant
- Partial incentives for staff and students according to ESSER Guidelines

<u>Proposed Expenditures (20% of allocation addressing learning loss = \$4,289,055)</u>

- Partial salaries and benefits of HQTs and Substitute Teachers
- Stipends for Historically Black Colleges and Universities Tutors
- Upgrade/replacement of technology within three (3) buildings
- Full salary and benefits of Social Worker
- Full salaries and benefits of seven (7) MTSS staff
- Full salary and benefits of MTSS Counselor
- Full salaries and benefits of Truancy/Outreach Workers
- Staff stipends for after-school programming, interventions, tutoring, etc.
- Full salary and benefits of Counselor
- Instructional/Intervention supplies and materials SAT, Credit Recovery (supplemental)
- Google Chrome Educational Upgrade

ESSER III State Set-Aside Allocation = \$556,172 (Targeted Funding)

Target 1: Additional Learning Loss Funding = \$397,266

- Full salaries and benefits of four (4) Professional Aides
- Full salaries and benefits of substitute teachers
- Instructional/Intervention supplies and materials (supplemental)
- Stipends and benefits for instructional teachers and aides professional learning Opportunities

Target 2: After-School Programming = \$79,453

• Social Emotional Learning Evidence-Based Programs

Target 3: Summer School Programming = \$79,453

- Instructional/Intervention supplies and materials (supplemental)
- Meals for identified summer students provided via Sodexo Food Services and/or approved food vendors.
- Teacher stipends for summer school programming such as AVID, Read 180, IB, and other approved evidence-based programs, interventions, tutoring, etc.
