ADDITIONAL NOTES

- 1. Driver's Ed Coordinators must teach Driver's Education
- 2. Coordinators need to be evaluated yearly for stipend
- 3. BTW certified teachers who want to drive get priority for Driver's Ed classroom
- 4. Best Teaching practices is that Driver's Ed classroom teachers participate in BTW
- 5. Repost for outside drivers at a \$30 hourly rate, posting will stay on the district website to attract applicants
- 6. All buildings will share BTW drivers after completion of all eligible students at driver(s) their home school
- 7. Priority of students BTW will be Seniors then DOB &/or classroom completion date
- 8. Complete the Drivers Ed Waiver for the 21/22 hour reduction waiver

If families elect to attain their BTW hours through a for-profit drivers education school they must receive a transcript and a letter from DL (during summer) or DE coordinator (during school year) that verifies that student has passed the classroom portion of DE and the amount of hours that particular student needs to meet the requirements set by the Secretary of State. The above data will tell you the hour requirement if the student completed the classroom portion during that school year.

During pandemic the following restrictions should be implemented:

- 1. Building procedures for electronic transcript attainment should be followed.
- 2. An electronic template for BTW DL or DE Coordinator letter should be generated.
- 3. Letters should be signed electronically and also sent to students through email.
