Resolution No. 25-21 certifies the Board's approval to submit the Continued Funding Application to the California Department of Education. The submission of the Continued Funding Application is required annually to renew the contracts that fund both the part-day and full-day California State Preschool and the California Prekindergarten and Family Literacy Support Programs. Included in the Board binders is an agreement with Community Response Education (CRE) to provide professional learning and curriculum development, teacher coaching and feedback, and Ethnic Studies district strategic implementation support in alignment with the Fresno Unified Ethnic Studies V.A.L.L.E.Y. Framework. CRE will provide job-embedded, Ethnic Studies support using the cycle of continuous improvement and will support the Ethnic Studies lead team in strategic implementation of Ethnic Studies. The Interim Superintendent recommends approval. Fiscal impact: Sufficient funds in the amount of \$100,000 are available in the Ethnic Studies Block Grant budget. C-11, APPROVE Agreement with Focus Five Inc

Included in the Board binders is an agreement with Focus Five Inc to provide virtual artist residencies at 40 elementary sites. The residencies, facilitated by professional teaching artists, include creative movement, drama, media arts, music, and visual art. Grade level teachers will also receive six optional virtual professional learning sessions on how to integrate art into their content to increase creativity and student achievement. The Interim Superintendent recommends approval. Fiscal impact: Sufficient funds in the amount of \$400,000 are available in the Student Engagement budget. C-12, APPROVE Agreement with WOW Productions

Included in the Board binders is an agreement with WOW Productions to provide lighting and sound design and technical support for productions and ensemble performances at Bullard TALENT K-8, a performing arts magnet school for students from all regions of Fresno Unified School District. WOW Productions has technical and design expertise to support student productions throughout the school year. These opportunities support language skills, reading, social-emotional development, student confidence, and will allow all students to learn and develop their skills in the California Arts Standards. The Interim Superintendent recommends approval. Fiscal impact: Sufficient funds in the amount of \$18,000 are available in the Bullard TALENT K-8 Block Grant budget. C-13, APPROVE Agreement Renewal with KnowBe4

Included in the Board binders is a 32-month agreement renewal with KnowBe4 to provide cybersecurity awareness training for staff. KnowBe4 is the world's largest integrated platform for cybersecurity awareness training and simulated phishing. KnowBe4 has the world's largest library of cybersecurity awareness training content, including interactive modules, videos, games, posters, and newsletters. The included phishing assessments simulate what bad actors are actively doing and see how employees apply their training. The Interim Superintendent recommends approval. Fiscal Impact: Sufficient funds in the amount of \$139,400 are available in the Information Technology budget. Contact person: Tami Lundberg, telephone 457-3560.

Assembly Bill 104, which established the Adult Education Block Grant, requires all consortium members be designated by the respective member governing Boards.
