

CORSICANA ISD STANDARDIZED DRESS CODE

TOPS must be:

- Polo-style or button-up.
- Spirit shirts are allowed. Articles must be worn in approved, **solid colors of blue** (light, royal or navy), **yellow** (light and gold), **white**, **black** or **gray**.
- Clubs and organizations may sponsor different colored shirts for special events, such as Pink Out, One Act Play, and ROTC.
- T-shirts may not be cut or altered in any way that changes the silhouette, shape, or basic construction of the original shirt.
- Collared with sleeves (short or long) in approved colors.
- Free of any visible logos, stripes, checks, lettering, wording or designs - EXCEPT approved CISD logos.
- Appropriately sized in the shoulders, sleeves, and length.
- Completely buttoned, except for the top two buttons.
- Sweaters and sweatshirts must be in CISD approved colors.
- Layering is acceptable, but undershirts must be in approved CISD colors.
- Shirts must cover the stomach and back when arms are raised and when seated.
- Sweaters and sweater vests without hoods are permitted and do not have to be tucked.

APPROVED COLORS



Tops (t-shirts, sweatshirts, polo, collared, sweaters) must be worn in approved, solid colors of **blue** (light, royal or navy), **yellow** (light and gold), **white**, **black** or **gray**.

- Form-fitting shirts, muscle shirts, see-through tops, midriiffs, and blouses with extreme low neck lines are not permitted.
- Sleeveless and thermal material shirts are only approved for layering in approved CISD colors.
- Logos other than the Corsicana "C" may be no larger than a credit card.

Wearing the same color pants and top at the same time is not permitted.

CORSICANA ISD STANDARDIZED DRESS CODE

Outerwear

- Solid jackets and sweaters without hoods are approved.
- Pullover sweatshirts without hoods are allowed in approved solid colors. The CISD logo, or the logo of a CISD school-sponsored organization, is optional.
- No denim or blue jean material jackets are allowed.
- Undershirts not in the solid colors of **blue** (light, royal or navy), **yellow** (light and gold), **white**, **black** or **gray** must be covered.
- Outerwear with hoods are not approved by CISD and should not be worn inside CISD buildings.



Not Permitted: Apparel with Hoods



Not Permitted: Leggings



Prohibited materials include lycra, spandex, poly/spandex and any other material that typically stretches as worn in athleisure wear.

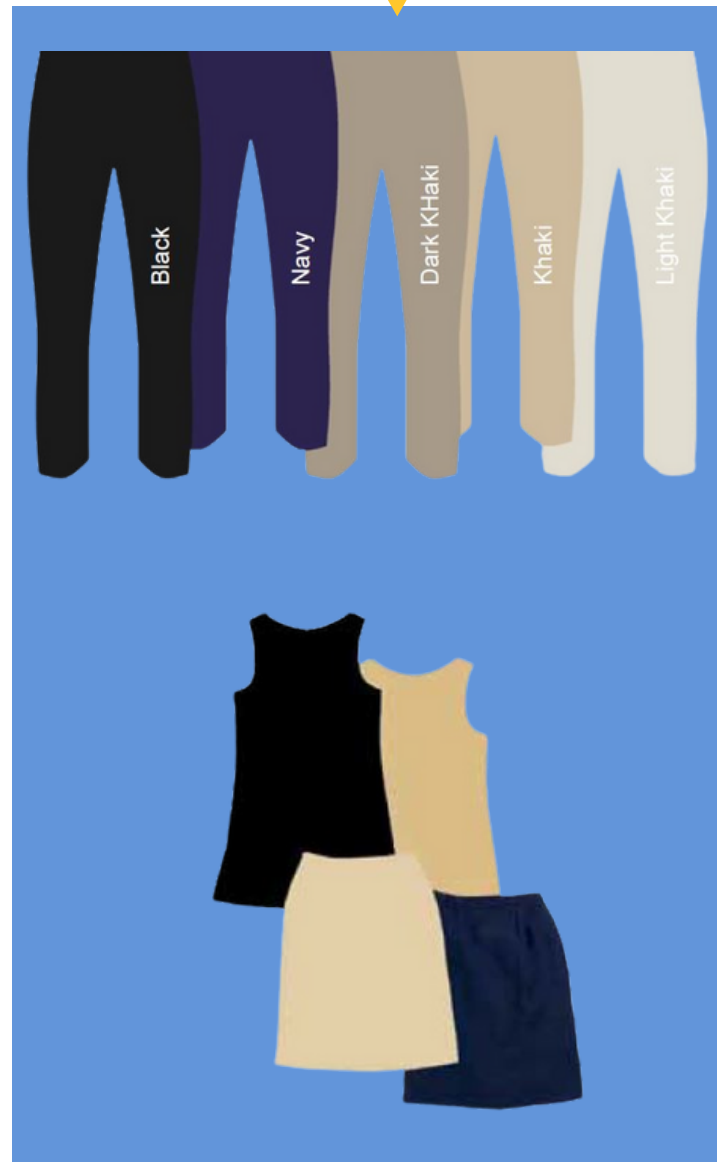
Bottoms pants/shorts

- Pleated or flat front Dockers style slacks or pants are approved.
- Pants & shorts must be in approved colors: solid khaki, navy, and black.
- Shorts must be fingertip length.
- No denim or blue jean materials are allowed.
- Cargo, carpenter, overalls, formfitting, low-rise, unhemmed, sagging and/or oversized style clothing are not permitted.
- Baggy-legged slacks or bell-bottom pants wider than shoes are not permitted.
- Wind shorts/pants, athletic shorts/pants, sweat shorts/pants are not allowed except as directed by the instructor during PE/athletics, cheer, band, or drill team classes.
- Brads, studs, zippers, and other adornments may not be worn.
- Leggings may not be worn as pants.

Bottoms skirts, dresses & capris

- Skirts, dresses & capris (girls only)
- Skirts, jumpers and dresses must be in approved colors: solid khaki, navy, and black.
- No denim or blue jean materials are allowed.
- Jumpers, dresses, and skirts for CISD must be no shorter than fingertip length.

- Jumpers and skirts may be worn with a dress code approved top.
- Capri pants for female students are allowed in approved colors.

Socks, Hose and Tights

- will no longer be governed

Belts

- optional

Footwear

- No flip-flops (V string through toe), slides, house shoes, or paramilitary type boots may be worn
- No rollers or wheels of any kind on shoes are allowed.
- Shoelaces must be worn as the shoe manufacturer intended.
