7. Information/Discussion Items:

A. Board Comments:

- Alicia Abifadel we had a former student band play at Orange Street Fair and they did great
- Crossing Guards throughout Orange are being reinstated throughout Orange
- o John Haug great class of Freshman from Santiago

B. Principal's Report:

- Enrollment: We are consistent with the enrollment we opened the 2024-2025 school year plus the Independent Study students we have added to the program. We currently have 1135 in-person students and about 20 Independent Study students residing throughout Southern California.
- Fundraiser: Kicking off the fundraiser this week with the schoolwide goal of \$50,000. This fundraiser helps to keep so many innovative opportunities Santanas have, at no cost.
- CHYA: We continue to work with the community and our staff on the adoption and rollout of the new CHYA curriculum. We will be going to the PTSA Meeting in September to get parent insight regarding the new adoption and rollout. This new curriculum will be in effect for students in the Spring of 2025.
- Back to School Night: We had a very successful Back to School Night this year with tons
 of parents. A huge shout out to our staff, parents and community for making this night
 memorable and supportive of the start to the school year.
- Long-Term Independent Study: We currently have over 20 Long-Term IS students
 utilizing curriculum from an accredited university and monitored and tracked by Santiago
 staff. These students have access to daily synchronous instruction with Santiago staff.
- GRIP: Santiago is proud to partner with OC District Attorney, OC Sheriffs and other local organizations to incentivize good attendance, behavior, and academics for some of our most at-risk students. Our staff learned more about local influences in a most recent PD.
- AC Units: Quotes pending on 100's, 400's, library, and admin building...all others are completed and working great.
- Fall Sports: Our after-school sports are underway and we are well into the Girls and Boys Soccer Season. A huge shout out to our Athletic Director, Mr. Connolly and Assistant AD, Mr. Nava, for creating these opportunities for students.
- We are going to make a significant investment in the fields this year, most likely during the holiday break as we have more activity than ever before and are in need of leveling off of some parts of the field as well as other field related repairs. We planned on this happening
- Attendance Rate: We are working with our attendance team to get on top of attendance from the start of the year. Students who are Open Enrollment and struggling with

- attendance already, are invited to parent meetings, etc. August Attendance: 97.47% AND September Attendance (up to 9/13): 96.18%
- STW: We have our first recertification meeting of the 2024-2025 School Year on 9/25. The California League of Educators will be visiting to affirm our application (turned in summer 2024) and recertify Santiago with another STW term starting in the 2024-2025 School Year. We are honored to be highlighting our rigorous academic programs, CTE-electives and some of the new programs we have at Santiago. We would love to invite any Charter Board members who are interested in attending the visit on 9/25. Please let us know and will give you all the details.
- O Grants: The Santiago Grant Team is working feverishly to get some early grants in for the 2024-2025 school year. 1) CTEig with focus on CTE and application written for \$523,000 (last year awarded 1/3rd so we are anticipating similar, hopeful of more). 2) SWP we are currently working on two different SWP applications, one on CTE electives and another on Dual Enrollment. We are hopeful to be awarded about \$400,000 between the two applications.
- OCSEA has reached an agreement with OUSD on contract negotiations. They have settled on a similar deal as OUEA and OUSD. Santiago has honored the equal to or better than clause by matching the CSEA/OUSD agreement at this time. The negotiations are all for the past school year and we are soon opening our 2024-2025 negotiations.
- El Rancho Charter just received a 7 year charter renewal...which only high performing schools can obtain. From what I witnessed, it went very well. Santiago would be eligible for the same 7 year- high performing term if we were up for renewal last year or even this year...but our term is usually on years ending in "5" or "0"...but all charter schools were backed up by 3 years due to COVID, instead of our charter term being up in 2025, it is now up in 2028. We will begin working on that renewal in 2025-2026 with a plan to present during the 2027 school year to avoid any last minute rush.
