

PARENT AFFIDAVIT OF RESIDENCY

In accordance with Maine residency laws, if a parent/guardian is subletting an apartment or home, or if more than one family shares a living space and there is only one leaseholder or homeowner, the parent/guardian must present the following:

1. **This completed form with the notarized “Address Affidavit” (see page 2)**, which is signed in front of a notary by the parent/guardian and primary homeowner/leaseholder affirming that the family is residing in this home, and
2. **A copy of the primary homeowner/leaseholder’s signed deed or lease.**
