As a Park Hill student enrolled in college courses at the Early College Academy MCC – Maple Woods half-day program, I understand the following:

- I am expected to follow all policies and procedures as outlined in the MCCCKC Student Handbook, which can be found at <http://www.mcckc.edu/our-students/student-handbook/>
- I am generating a permanent college record that will be applied to all of my higher education pursuits after I graduate from high school. This will include the credit hours attempted and earned and grade point average (GPA).
- My college grades may have an effect on my future college financial aid. Failing, withdrawing, or being dropped from a class may affect my eligibility for financial aid in the future.
- Park Hill – MCC Maple Woods ECA courses are college courses requiring a level of responsibility and maturity expected from a college student. These courses will require rigorous academic work.
- It is the responsibility of the parent/guardian to assure that their student is able to handle the college environment, as well as the content of the courses in which the student enrolls.
- I am aware that regular classroom attendance and participation are a requirement. Failure to attend may affect my grade and the instructor may drop me from the class if I do not attend. Being dropped from a college course will affect your progress toward your high school diploma.
- I am expected to attend classes both on the Park Hill and MCC-Maple Woods Academic Calendar. I am aware that there may be times MCC is in session when Park Hill is not, and I know to attend class. I am aware that there may be times Park Hill is in session when MCC is not, but I may be required to attend school for the full day.
- Certain information necessary for enrollment into the ECA may be exchanged between high school administrators, counselors, and the college. Student information may include, but is not limited to: student identification number, test scores, social security number, attendance, midterm and final grades, etc.
- Students who earn a grade of a D or F in, or withdraw from, any of the college courses taken as a part of the ECA will be required to reimburse Park Hill at a rate of \$60.50/credit hour of the course with the grade of a D, F, or W. (This discounted high school rate is 50% of the regular MCC tuition rate, which is set by MCC's Board of Trustees and is subject to change.)
- I certify that none of the information I have provided on my application is false or has been withheld. I understand that giving false information or withholding information may make me ineligible for admission or continuation at MCC- Maple Woods.

Parent/Legal Guardian agrees to the following:

I agree to support my child in being successful. I understand that the final grades for any college course that my child may take will become part of his/her academic and financial aid permanent record for both high school and college. I agree to comply with all rules, regulations, and requirements at MCC – Maple Woods. I authorize ECA to release academic information to any organization that is providing funding for my education.

As a student and parent/guardian of this student, I agree to support Park Hill Early College Academy at MCC-Maple Woods expectations of student participants. These expectations include:
