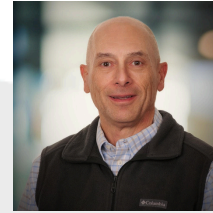

The Pocatello/Chubbuck School District 25 has initiated a review of its enrollment and attendance areas to address recent shifts in district-wide enrollment. The district is committed to ensuring that school facilities are used efficiently and that student enrollment aligns with the capacity of each building to maintain a high-quality educational environment.

To tackle these evolving challenges, the district has formed two sub-committees. The purpose of the committees is to review the district's elementary and middle school attendance and enrollment areas, provide input, analyze data, and advise the Board to inform any decision-making impacting PCSD 25's enrollment and attendance areas. The district plans to review high school enrollment and attendance areas beginning in spring 2025.

## PCSD 25's Capital Improvements Program - CIP

The Capital Improvements Program, often referred to as CIP (sip), is the planning instrument PCSD 25 uses to identify needed capital projects (i.e. building construction, building repair and remodeling, and building equipment), to coordinate financing, and to schedule improvements in a way that maximizes the use of public funds. CIP balances project requests with current and future School Plant Facilities or bond proceeds. The coordination and scheduling of improvements are determined by the district's CIP committee, board-approved, and then tracked in the district's CIP replacement schedule document. Resources for CIP are generally estimated in October or November each year.
