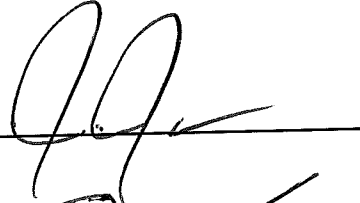
REGULAR CALLED MEETING
