ATHLETIC PARTICIPATION AGREEMENT

"I, _____, authorize the Iberville Parish School Board to conduct test on urine specimens, which I will provide, to test for drugs. I also authorize the release of information concerning the results of which test to the Iberville Parish School Board though its agents (the Superintendent and/or his designee) and to my parents and/or guardians. This form shall remain in effect for the remainder of the student's eligibility unless the student transfers to another school.

If I am or have been taking prescription medication, I acknowledge that I may provide verification (either by a copy of the prescription or by doctor's authorization) prior to being tested. I am aware this requested information concerning prescription medication is voluntary and shall be provided in a sealed envelope, and the contents therefore will only be used by the testing agency if needed.

I am fully aware of the Iberville Parish School Board policy on drug and use and also the additional rules set forth by my schools' athletic department. I understand that should I violate these rules, I am subject to severe penalties including loss of athletic privileges.

NO STUDENT SHALL BE TESTED UNLESS THE PARENT OR GUARDIAN AND THE STUDENT SIGN THIS FORM PERMITTED THE PERFORMANCE OF THE SUBJECT TESTS. BY SIGNING AND SUBMITTING THE DRUG TEST AUTHORIZATION AND CONSENT FORM, THE PARENT OR GUARDIAN AND STUDENT ACKNOWLEDGE THAT THEY HAVE CONSENTED TO THE ADMINISTRATION OF THE TEST AND WAIVE ANY CLAIM OF INVASION OF PRIVACY ANY WAIVE ANY OBJECT TO THE ACTION WHICH MAY BE NECESSARY IN THE IMPLEMENTATION OF THIS DRUG TESTING PROGRAM AND IN FURTHERANCE OF THE GOALS WHICH SERVE AS ITS BASIS AND SHALL ALSO BE UNDERSTOOD THAT BY AGREEING TO ANY TEST, THE PARENT OR GUARDIAN AND THE STUDENT AUTHORIZED THE IBERVILLE PARISH SCHOOL BOARD TO HAVE THE TESTS ENUMERATED HEREIN ADMINISTERED AS A NECESSARY AND MANDATORY RESPECT FOR PARTICIPATION IN ITS ATHLETIC PROGRAMS. REFUSAL TO SIGN THE FOLLOWING FORMAND/OR TO SUBMIT THE TEST SHALL CONSTITUTE IMMEDIATE NOTICE THAT THE STUDENT SHALL NOT BE PERMITTED TO PARTICIPATE OR CONTINUE TO PARTIPATE IN ATHLETICS OFFERED BY THE LHSAA.
