Types of Funding Available

Affording private school, how can you make it happen for your child? How can you invest in your child's future?

Catholic, private education comes with a price tag. Some people plan for this, some do not. There are several vehicles to help reduce the impact on your family's financial landscape.

- Internal Scholarships/Financial Aid
- External Scholarships/Financial Aid



FACTS Grant & Aid Assessment

What is FACTS Grant & Aid Assessment?

FACTS Grant & Aid Assessment is an independent, third-party company that utilizes your information to prepare a financial analysis in determining your family's financial need. This tool is utilized by various groups to assist in the distribution of financial assistance, grants, and scholarships.

Saint John's Catholic Prep, Archdiocese of Baltimore, Frederick County Parish Tuition Assistance Fund, and Friends of Catholic Education receive a confidential report outlining your financial picture based on the information provided by you on the online application and through your tax documents. This report, along with your family's total tuition amount, is used in determining your financial need. The various groups all use this information in determining tuition assistance awards.



FACTS Grant & Aid Assessment

Documents Needed to apply in FACTS:

- Your 2023 and 2024 federal income tax return, with all supporting schedules.
Note: If applicant and co-applicant file separately, we require both tax returns for the same year.
- Copies of all 2023 and 2024 W2s for both applicant and co-applicant as soon as available.
- If you do not file a tax return, you are required to provide documentation of all income received.
- FACTS deadline February 5, 2025.



FACTS Grant & Aid Assessment

Other items for FACTS:

- On the assessment, it is useful for the reader if the applicant uses the narrative section to provide additional information regarding current financial situation that can't be ascertained through numbers.
- Must indicate parish on assessment.
- **IMPORTANT**, to be considered for *any* financial assistance, grants, and/or scholarships through Archdiocese of Baltimore (AOB), Frederick County Parish Tuition Assistance Fund (FCPTAF), Friends of Catholic Education (FOCE) or Saint John's Catholic Prep (SJCP), **you must apply through FACTS Grant & Aid Assessment.**



YOU ONLY NEED TO APPLY ONCE, BUT YOU MUST REAPPLY EVERY YEAR

Internal Scholarships and Grants

Academic Scholarships (documents already provided during Admissions process) Awards determined by:

- Report Cards/Official Transcript
- Teacher Recommendations
- HSPT scores

Internal Scholarships and Grants

Catholic School Employee Grant

- \$2,000 grant for the first child
- \$1,000 for each additional child if either parent is an employee at a Catholic School
- Employment must be verified
- Only one parent eligible
- Grant is applied for each year student is enrolled

Other Internal Grants

- SJCP receives grant money from a variety of external sources that we award to students who show need.

SJCP has no input on these awards and communication should be with the outside organization, not with SJCP.

SJCP will be made aware of all awards given, but please inform the Admissions office once you receive an award so that we can document in your file.



External Scholarships/Grants

FRIENDS OF CATHOLIC EDUCATION SCHOLARSHIP

- FACTS Grant & Aid Assessment must be submitted by March 15th for the FOCE application to be considered
- Parents will be notified in February by email when the FOCE application is available
- Principal and teacher input required
- DEADLINE: Completed applications with ALL documents returned to SJCP by **March 15, 2025**. No applications will be accepted after this date



External Scholarships/Grants

FREDERICK COUNTY PARISH TUITION ASSISTANCE FUND

REQUIREMENTS

- Your family must be registered at one of the following Frederick County parishes:
 - St. John the Evangelist
 - St. Katharine Drexel
 - St. Peter the Apostle
 - St. Timothy
 - St. Joseph-on-Carrollton Manor
 - Holy Family Catholic Community
 - St. Ignatius of Loyola
 - St Francis of Assisi/St. Mary



External Scholarships/Grants

FREDERICK COUNTY PARISH TUITION ASSISTANCE FUND

- Your family must be an active, registered member of the parish and contribute financially on a regular basis.
- Deadline: Applicants must apply through **FACTS Grant & Aid Assessment by March 31, 2025**
- Must indicate Parish affiliation on FACTS Grant & Aid Assessment
- Awards will be made based on family need and the requirements of the Frederick County Tuition Assistance Fund
- Parish awards will be made no later than June 1, 2025



External Scholarships/Grants

BOOST SCHOLARSHIP PROGRAM

- The Broadening Options and Opportunities for Students Today (BOOST) program can provide scholarships for students who are eligible for the free or reduced lunch program and attend eligible nonpublic schools. SJCP is an eligible school.
- Established in March 2016 by the Maryland State General Assembly, administered by MSDE.
- Scholarship Program will continue as long as the program is funded by the state.
- Currently, students who are already BOOST recipients and their siblings are eligible. This can change based on the Maryland State General Assembly.

External Scholarships/Grants

West Virginia Hope Scholarship Program

- The West Virginia Hope Scholarship Program is the state's education savings account program.
- The scholarship allows K-12 students to receive financial assistance that can be used for tuition and other qualifying expenses at designated schools. SJCP is one of those schools.
- Participation is dependent on your student's enrollment for the previous academic year.

KNOTT SCHOLARSHIP

- The Knott Scholarship Funds award four-year, full-tuition scholarships to attend a Catholic Elementary or Catholic High School. These scholarships honor Catholic students who excel in academics.
- The application can be found at knottscholar.org
- Click “Secondary Scholarship”
- Find “How to Apply” and click on the link.
- Parents can begin their child’s application in the online portal. The portal officially opens January 20, 2025, for the following academic year. They must be submitted no later than **5:00 pm on Thursday, February 27, 2025.**

SJCP Financial Aid

- Deadline – February 5, 2025
- 2023 taxes and 2023 and 2024 W2s in FACTS Grant and Aid Assessment for Early Application Status, 2024 taxes submitted as soon as possible once completed
- Rolling – ongoing until available aid is gone

Internal Scholarships

- Deadline – February 5, 2025
- Rolling – ongoing until available aid is gone



Timeline

Acceptance Notification Date – February 15, 2025

- Admissions decision via email
- Enrollment Contract with Financial Aid Package available through Blackbaud

Deposit with Signed Enrollment Contract and Payment Plan – March 7, 2025

Acceptance of Adjusted Enrollment Contracts and Financial Aid – June 27, 2025
