NOTICE OF ELECTION

The Wisconsin Employment Relations Commission will be conducting a secret ballot election to determine whether fifty-one percent (51%) of the employees of the Verona Area School District in an existing teacher bargaining unit want to continue to be represented by the Verona Area Education Association, WEAC Region 6 for the purposes of collective bargaining.

You may vote any time between noon on Thursday, November 7, 2024 and noon on Wednesday, November 27, 2024. You cannot change your vote after it is cast. When the voting period ends, the Commission will provide the results to the Employer and the Labor Organization.

You can vote by telephone (toll free at 1-888-572-2350) or online (<https://werc.elections.vote>). The voting system is in operation 24 hours a day, 7 days a week, during the voting period. The following are the instructions for voting:

1. Be prepared to provide the first four letters of your last name and the last four digits of your Social Security number.
2. Follow the instructions provided to you by telephone or online.
3. After you vote “yes” or “no,” you will be asked to confirm your choice. You must confirm your choice for your vote to be counted.

DIRECTION OF ELECTION

Verona Area Education Association, WEAC Region 6, hereinafter referred to as the Petitioner, having filed a petition with the Wisconsin Employment Relations Commission, requesting the Commission to conduct an election, pursuant to § 111.70(4)(d)3.b. of the Municipal Employment Relations Act, among certain employees in the teacher bargaining unit of the Verona Area School District, to determine whether said employees want to continue to be represented by the Petitioner for the purposes of collective bargaining; and the Commission being satisfied that such an election should be conducted;


NOW, THEREFORE, it is

DIRECTED

That an election by secret ballot shall be conducted under the direction of the Wisconsin Employment Relations Commission among all employees in the teacher bargaining unit, who were employed on September 06, 2024, except such employees¹ as may prior to the election leave or be removed from the bargaining unit, for the purpose of determining whether at least fifty-one percent (51%) of the employees in the bargaining unit want to continue to be represented by the Verona Area Education Association, WEAC Region 6 for the purposes of collective bargaining with the Verona Area School District.
