

**West Valley Central School Board of Education**

**Re vote Budget Hearing**

**June 11, 2018**

Hearing called to order at 7pm with Carolyn Boberg, District Clerk presiding.

Carolyn Boberg, District Clerk read the Propositions listed on the Legal Notice of West Valley Central School.

**NOTICE IS HEREBY GIVEN** that the Annual Budget Hearing, where school administrators will present the proposed 2018-2019 school budget for the West Valley Central School District (the "District"), will be held on Monday evening, June 11, 2018 at 7:00PM EDT in the WVCS Auditorium.

**NOTICE IS ALSO HEREBY GIVEN** that the Annual Budget Vote and School Vehicle Purchase Vote will be held on Tuesday, June 19, 2018 from 12:00 noon to 9:00PM EDT in the WVCS Gymnasium.

**The purpose of voting will be on the following two propositions:**

**PROPOSITION NO. 1**  
**PROPOSED 2018-2019 BUDGET**

Copies of the proposed budget and the propositions will be available in the District's Main Office, fourteen (14) days beforehand, upon request, to District residents during normal school hours (8:00AM – 4:00PM EDT) Monday through Friday. Copies will be available at the Budget Hearing and during the time of voting.

**PROPOSITION NO. 2**  
**(1) 22 Passenger Chevy/Collins school bus**

**BE IT RESOLVED** that the Board of Education (the "Board") of the West Valley Central School District (the "District") is hereby authorized to purchase one (1) 22-passenger Chevy/Collins school bus, model C/T G33503 and related school vehicle equipment for use in the transportation program of the District, at an estimated maximum combined cost of \$53,232, being the aforesaid estimated maximum cost, or so much thereof as may be necessary, shall be raised by the levy of a tax upon the taxable property of the District and collected in annual installments as provided by Section 416 of the Education Law, and, in anticipation of such tax, bonds or other obligations (including, without limitation, obligations arising under leases, lease/purchase contracts or installment purchase contracts having a term of not more than five years) of the District shall be issued or entered into in accordance with applicable provisions of New York State law.

Carolyn Boberg introduces Ann O'Brien, Business Official to give a presentation of the 2018/2019 budget. On the ballot again will be the proposed 2018-19 budget of \$9,184,125, a 0.97 percent increase from last year, with a two percent increase in the tax levy, as well as a proposition to purchase a new 22-passenger school bus at the cost of \$53,232. She explained the budget and bus proposition in detail, followed by Dan Amodeo talking about the courses, extracurricular activities and other programs offered within the district. The local share of the bus is estimated at \$11,818. At the end of her presentation, she took questions and comments from community members. Norb Warnes complimented the board and administration for what is offered to the students of a small school and asked about the administrative part of the budget. Tim Zerfas asked the maximum/minimum number of students in West Valley college courses. Steve Wedvik had a question regarding the reserve fund amounts and Scott VanBuskirk cost per student.
