VII. REPORTS

A. Superintendent, Eric Lawton attended the JMT Joint Management Team conference at Holiday Valley Thursday and Friday last week. He conferenced with fellow superintendents from all across Western New York. He attended a lecture/discussion by George Couros, Jill Berkowicz, Jazz Conboy, and Rich Ognibene – it was excellent.

Ryan Keem was approved by Iroquois Central School for a science teacher position. We have not received a resignation letter from him. But Dan has already begun the process of finding a replacement. Eric wanted to let the BOE know that there are times when he hears of a staff member applying for a different job, but he does not let the BOE know until they are actually hired.

The project is moving along and the good news is that we will save some money with the waiver from NYS to be able to fill in the stairwell in the back. We will have to put in a rescue window and escape ladder, but that will be less costly than replacing the entire concrete wall. Windows are going into the bus garage and the auditorium stage ceiling has been removed. The concrete in the hallways needs to set up for a period of time before we can put new tile down, so that may not be 100% complete before the start of school. For the most part we are on schedule. Asks BOE their thoughts on the auditorium curtain emblem. The BOE thought WVCS letters straight across would be nice.

On the agenda there is a motion for the resignation of April Preston. He thanked her for the years of service and dedication. Wishes her all the best as she steps into a full time administrative position at Catt-Little Valley.

And...

WHEREAS, The Board of Education, West Valley Central School District of New York State is desirous of participating with The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties in the joint bid of the commodities and/or services mentioned below as authorized by General Municipal Law, Section 119-o... And...

WHEREAS, The Board of Education, West Valley Central School District of New York State has appointed The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties as representative to assume the responsibility for drafting of specifications, advertising for bids, accepting and opening bids, tabulating bids, reporting the results to the

Board of Education, West Valley Central School District of New York State and making recommendations thereon...

NOW, THEREFORE, BE IT RESOLVED, That The West Valley Central School District on behalf of the Board of Education, West Valley Central School District of New York State hereby is authorized to participate in cooperative bidding conducted by The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties for supply of electricity and if requested to furnish The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties an estimated minimum number of units that will be purchased by The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties. The Board of Cooperative Educational Services of Ontario, Seneca, Wayne and Yates Counties is hereby authorized to award cooperative bids to the bidder deemed to be the lowest responsive and responsible meeting the bid specifications and otherwise complying with Article 5-A of the General Municipal Law of the State of New York relating to public bids and contracts.
