The following letter was received June 30, 2015;

Dear Superintendent Lawton,

I am pleased to announce that I have successfully secured additional state funding as a grant-in-aid ("bullet aid") for West Valley Central School in the amount of \$50,000.

This bullet aid is intended to help with the ongoing fiscal challenges you face in your school budget and to help you with some program restorations. I have been concerned with your budget challenges, and in particular with the long-lasting effects on the school district of the West Valley Nuclear Development Project and the Western New York Nuclear Service Center.

As you know, for several years I have sponsored legislation to increase your payment-in-lieu-of-taxes (PILOT). Although the Governor has not been willing to support proposals to increase the PILOT. I continue to be concerned and look for ways to help your school. Therefore, I am very happy that I was able to help secure this additional bullet aid for you this year.

The bullet aid grant was approved during the 2015-16 state budget process and was finalized at the end of the 2015 Legislative Session. It will shortly be processed by the New York State Education Department and the Division of Budget. The funds must be used in the current school fiscal year ending June 30th, 2016. A copy of the adopted Senate Resolution number R3050 that allocated this funding to you.

This funding is being given to West Valley Central School because I recognize that this additional funding will help you enhance and support your ongoing educational programs.

Thank you for your continued dedication to our students and communities. If you have any questions, feel free to contact me. Please accept my best wishes for a successful new school year in 2015-16.

Whereas, a proposition authorizing the Board of Education to purchase a school bus at an estimated total cost of \$108,000.00 was included in the Notice of Annual Meeting and Election of West Valley Central School District, and said proposition was put before the qualified voters of the District at the Budget Hearing of the West Valley Central School District on May 11, 2015, and said proposition was thereafter voted upon and approved by the qualified voters of said district on May 19, 2015, and

Whereas, said proposition provided that all or part of the cost of the school bus was to be financed by the issuance of obligations pursuant to the Local Finance Law, and also provided that the School District was authorized to levy a tax upon the taxable property of the district in the amount of \$108,000.00 to be collected in annual installments as provided by law, in such years and in such amounts as may be determined by the Board of Education, and

Whereas, a contract was duly entered into on or about March 26, 2015 with Leonard Bus Sales, Inc. covering the purchase of a 65 passenger school bus at the cost of \$108,000.00, and

NOW, THEREFORE, BE IT RESOLVED:

The specific object or purpose for which obligations are to be issued 1. pursuant to this Resolution is to finance the cost of a new 2015 IC 65 Passenger School Bus VIN #4DRBUAAN3GB741153.

The maximum cost of such equipment is \$108,000.00 and the plan 2. of financing such cost is as follows:

> Α. No down payment will be provided by current funds.

Β. The balance of the cost is to be provided by the issuance of Serial Bonds in the amount of \$108,000.00 pursuant to this Resolution. 3.

The following determinations are hereby made:

A. The period of probable usefulness of such equipment is five

years.

B. The subdivision of Paragraph A of Section 11.00 of the Local Finance Law which is applicable in the circumstances is Subdivision "29".

C. The proposed maturity of the obligations authorized by this Resolution will not be in excess of five years.

4. No down payment has been provided as same is not required under the provisions of Section 107.00(5) of the Local Finance Law.

5. The form and contents of the bonds to be issued are left to the further action and Resolution of this Board.
