B. Business Official, Michael Chudy distributed and reviewed copies of the 2011/2012 budget.

Moved by Jackson-McCarty, Seconded by McCauley that the Board of Education of the West Valley Central School District adopts the proposed purchase of one (1) 65 passenger school bus at a cost not to exceed \$108,000 and one (1) school mini-van at a cost not to exceed \$30,000; and the District borrows such funds to cover the aggregate cost of the purchase, and to issue its Serial Bonds and to refund such bonds by a tax to be collected in installments in accord with the provisions of the Education Law and Local Finance Law, and/or to enter (at discretion of the Board of Education) into one or more Lease/Purchase Contracts (or substantially similar contractual arrangements) having a term of five years or less, with respect to the acquisition of one or more of such buses. 6 ayes, 0 nays, motion accepted
