

SUMMARY ANNUAL REPORT FOR THE ALEXANDER DAWSON SCHOOL 401(K) PLAN

This is a summary of the Form 5500 Annual Return/Report of Employee Benefit Plan for the The Alexander Dawson School 401(k) Plan, EIN 22-6044616, Plan 003, for period January 1, 2023 through December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), participant-directed brokerage account, default investment account, pre-approved, controlled or affiliated service group member, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$1,459,240. These expenses included \$40,986 in administrative expenses and \$1,418,254 in benefits paid to participants and beneficiaries. A total of 468 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$34,737,241 as of December 31, 2023, compared to \$28,983,766 as of January 1, 2023. During the plan year, the plan experienced an increase in its net assets of \$5,753,475. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$7,212,715, including employer contributions of \$765,973, employee contributions of \$1,266,312, other contributions of \$125,558 and earnings from investments of \$5,054,872.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
