### **MS Athletics and Donations**

It is the Mission of the Livermore Valley Joint Unified School District Athletic Department to inspire each student to extraordinary achievement every day. We provide a comprehensive athletic program that emphasizes the development of lifelong learning, values and skills through hard work, sportsmanship, ethical conduct, and fair play. During each season of sport, the school's athletic department may ask for donations to contribute to the expenses of uniforms, equipment, and officials. While any donation is appreciated, the suggested donation amount is \$100 per sport. The California Constitution's free school guarantee prohibits charging students any fee, charge, or deposit for extracurricular, credit, or non-credit activities that are part of the District's or school site's educational program. Though many programs request parent/guardian donations, which are permissible, these donations are not mandatory. Donations should be made through the school's webstore found on the school's website. Donations are not refunded. All donations will be made to the General Athletics Account. Donations in any amount are very much appreciated and will be equitably distributed to athletic teams in compliance with Title IX.

**ATHLETIC ELIGIBILITY/REQUIREMENTS/DICIPLINE: (IMPORTANT Please Read Carefully)**

1. A “Current Year Physical Form” with verification of an annual physical must be on file in the Office.
2. Students must maintain a **2.0 GPA** and be passing in **ALL** classes with a ‘**D**’ or better for each grading period. Boys’ basketball eligibility for 7th grade will be determined by the previous year’s final report card.

Each grading period students must maintain a 2.0 GPA and be passing all classes with a D or better. A student is not eligible with an “F”. Eligibility is determined from each trimester report card distribution to the next trimester report card distribution. Boys’ basketball eligibility for 7th and 8th grade will be determined by the previous year’s final report card. Per District Policy you may request “one time” probation for one grading period. This must be in writing from the student and parent and can be used once during your middle school athletic years. This request will be kept in your permanent file for reference.

A current year “Physical Form” with verification of an annual physical must be on file with the Athletic Director.

**Teacher Referral**

**Basketball** – Player will be benched for the first quarter of the game for each teacher referral, if more than one teacher referral, the whole game.

**Wrestling** – Player will not participate in the first match in a Dual Meet.

**Volleyball** – Player will not participate in half of a match in a 2 out of 3 game set.

**Track** – Player will not participate in the first event of a track meet.

**Golf** – May not participate in a round.

**Suspensions ~ All Sports:** If a player receives a suspension, they will not be able to practice or play until the suspension is served and **will not** be allowed to play in the Game/Match/Round/Meet following the completion of their suspension.

If a player receives a **second** suspension, they will be released from the team and will no longer be allowed to participate in any manner with the team.

**Absences** An athlete must attend school for at least 4 periods to be eligible to participate in that day’s competition.
