

MINUTES Clint ISD SCHOOL HEALTH ADVISORY COUNCIL Clint ISD – Central Office May 28, 2020

- 1. Introduction/Welcome The meeting began at 9:04 AM. This was an online virtual meeting.
- 2. Mr. Swanson updated the committee on the Unlicensed Diabetes Care Assistant (UDCA) documentation. He sent the new UDCA form, in both English and Spanish, to campuses. The form asks for permission from parents to allow trained personnel to help students with diabetes in times when a nurse was not available. The form is now available to all nurses across the district.
- 3. The warehouse delivered new middle school health textbooks in March. They will be a welcome addition to the new school year.
- 4. The Commissioner of Education cancelled FitnessGram for the 2019-2020 school year. There has been no formal announcement for the upcoming school year.
- 5. Mr. Swanson detailed Covid 19 response plans from Clint ISD as provided by district leadership, the Commissioner of Education, and the Governor of the state of Texas. The plans included information on holding summer school, opening of school gyms for major sports, potential plans for opening of schools to include (A/B) block schedule and the current research to protect our community from Covid 19.
- 6. Mrs. Bailon, the Director of Counseling, discussed Social and Emotional Learning as well as plans for counselors in the 2020-21 school year. She shared Counselors Corner the district Clint counselor's web site that provides resources for students and parents during remote learning. The website also includes information on credits and programs in Clint ISD such as PTECH which she will talk about in a future meeting.
- 7. Mrs. Lail discussed the swift response to feeding the students in Clint ISD as campuses closed due to the Corona virus in mid-March. The district Child Nutrition Program is now providing hot meals across the district from campuses as well as delivery locations around the district. She told the committee that the district is providing between 12, 000 13, 000 meals per day through a pick up process at each campus or through a delivery process while still following USDA guidelines for being nutritionally balanced. Mrs. Lail also answered parent questions on when frame of meal delivery and availability. She also told the committee that 3 campuses would be

closed for the summer. Those campuses are Surratt Elementary – students will pick up meals at Clint Junior, Carroll T. Welch – students will pick up their meals at Frank Macias Elementary and Horizon MS – students will pick up their meals at Desert Hills Elementary. Mrs. Lail also informed the committee that all staff were trained in safety processes when distributing meals.
