

## RESOLUTION

### **A RESOLUTION PROVIDING FOR THE ANNUAL ELECTION FOR SCHOOL BOARD MEMBERS OF THE WRIGHT CITY R-II SCHOOL DISTRICT OF WARREN COUNTY ON APRIL 8, 2025.**

WHEREAS, the laws of the State of Missouri provide that an annual election for directors of the District shall be held every year and provide for certain duties of the Board of Education of the District in regard to said election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE WRIGHT CITY R-II SCHOOL DISTRICT, AS FOLLOWS:

1. Said election will be held on April 8, 2025.
2. The purpose of said election is to elect **two (2)** full-term directors from the District to serve from the date of said election until the first Tuesday following the first Monday in April 2028. Any qualified person who desires to be a candidate for the above School Board may have his name placed upon the ballot by filing his written declaration of such candidacy for director and a statement that he possesses the required qualifications with the Secretary of the Board. Candidates may file in the Central Office at 90 Bell Road in Wright City beginning at 8:00 a.m. on December 10, 2024, and continuing during the district's regular business hours which are Monday through Friday from 7:30 a.m. to 3:30 p.m., except for the first and last day of filing. Candidate filings will not be accepted on days when school is canceled due to inclement weather or on December 23, 24, 25, and 30 when the district's offices are closed. The office will be open for one hour on December 31st starting at 4:00 pm and filing will end on December 31st at 5:00 pm. Names of qualified candidates shall be placed on the ballot in order of filing.
3. The Secretary of the Board shall cause notice of such filing deadline to be published in The Warren County Record on November 28 and December 5, 2024.
4. Said election shall be held at the following voting places in said District, to-wit:

and the polls shall be opened by six o'clock in the morning and shall remain continuously open until seven o'clock in the evening.

5. Said election shall be held under the provisions of Chapter 115 R.S.Mo.
6. No election will be held if, after the last date of candidate filing, the number of candidates who have filed is equal to the number of positions to be filled by the election. However, if the number of candidates filing exceeds the number of positions, the election will be held even if a sufficient number of candidates withdraw so that the remaining candidates are equal to the number of positions to be filled.
7. All duties specified in the state election laws, unless otherwise specified, are to be performed by the officer or agency calling the election, and all duties specified in the state election laws, unless otherwise specified, to be performed by the District shall be performed by the Secretary of the Board.
8. Within fourteen days after the election and after the results of the election shall have been certified to the District, the Board of Education of the District shall meet and order the Secretary of the Board of Education to issue certificates of election to the persons entitled thereto and the board shall organize by the election of a president and vice president.
9. This resolution shall take effect and be in force from and after the passage and adoption hereof.
