All Birth Certificates (Veteran, Spouse & Dependents)	Pay Check Stubs
Marriage Certificate	Unemployment Benefit Letter

2. The Financial Assistance Intake Packet must be completed **PRIOR to 4:00 p.m. on November 19th, 2024.**

Plan ahead! You will need to physically visit the following locations:

1. **Illinois Department of Employment Security**
 2. **Department of Human Services**
 3. **Social Security Office**
3. **Make a follow up appointment to receive your voucher on November 20th.** Due to the anticipated volume, an appointment must be made to receive your voucher.
