The plan will explain how the LEA will use the funds it receives through the Expanded Learning Opportunities (ELO) Grant to implement a learning recovery program for at least the students included in one or more of the following groups: low-income students, English learners, foster youth, homeless students, students with disabilities, students at risk of abuse, neglect, or exploitation, disengaged students, and students who are below grade level,

including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

## Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Information gathered during a survey of parents, teachers, and school staff, during the months of June and July 2020, indicated a need and desire to provide instruction to address learning loss during the pandemic. Additionally, parents, teachers, and school staff were all invited to complete a detailed survey during March, 20-21, to gather specific input to determine the goals, actions, and budget priorities for the district for summer and 2021-22 school year. Over 50% of our parents and staff completed the survey and survey results have been reviewed to identify priorities, including Expanded Learning Opportunities to address student learning loss.

The survey focused on the eight areas identified as state priorities. The survey results and final plan demonstrate how the district's budget will help achieve the survey goals.

A description of how students will be identified and the needs of students will be assessed.

To identify students who have experienced significant learning loss due to the school closures in 2019-20 and the remote learning during 20-21, Monroe Elementary solidified a systematic cycle of assessments, including initial screenings and formative and summative assessments using iReady system of assessments. Monroe Elementary will use this data to develop an instructional schedule model to address student needs with a focus on implementation of intervention strategies to accelerate learning for students at risk of experiencing continued learning challenges due to the impacts of COVID-19 and ongoing distance learning. Students will be prioritized by needs identified on given screeners as those that illustrate the most needs. Those students will have extended learning time during the summer months whereas; learning loss mitigation will be the focus in the areas of ELA and Math. All students will be provided a healthy breakfast and a healthy lunch.

A description of how parents and guardians of students will be informed of the opportunities for supplemental instruction and support.

Parents and guardians will be contacted, with translation provided as necessary, by staff members to discuss opportunities for supplemental instruction and support. Specific details will be shared regarding the instructional options to address student learning loss. Each will be informed of the reasons why students have been identified and what each should expect from the instruction, intervention strategies, and assessment data. Each will be strongly encouraged to have their student's participate.

A description of the LEA's plan to provide supplemental instruction and support.

The district will provide 12 days of Expanded Learning Program during July, 2021. Mathematics and reading/writing will be the main focus for curriculum and intervention strategies during this time. Each day, approximately 2 hours will be dedicated to focused instruction in each area:

mathematics and reading/writing. District certificated and paraprofessional staff will provide the instructional planning, delivery, assessment, and results.

Elementary and Secondary School Emergency Relief (ESSER) funds will be utilized during the Expanded Learning Sessions in coordination with the Expanded Learning Opportunity (ELO) Grant. All student populations will receive, to the extent permissible under the guidelines of the United States Department of Agriculture, meals for breakfast, lunch and supper. Transportation will be provided for all students who attend the Summer Expanded Learning Sessions and all materials and supplies necessary for the program will also be provided.

The Expanded Learning Opportunities Grant Plan must be completed by school districts, county offices of education, or charter schools, collectively referred to as Local Educational Agencies (LEAs), that receive Expanded Learning Opportunities (ELO) Grant funds under California *Education Code (EC)* Section 43521(b). ## Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- “Supplemental instruction” means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- “Support” means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students’ needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- “Students at risk of abuse, neglect, or exploitation” means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

*EC* Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
  - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
  - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
  - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

### **Fiscal Requirements**

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
