3. The Board of Education reserves the right to reject any and all bids.
4. Bids shall be binding for a minimum of 30 days from the date of opening.

Bids MUST be submitted in a sealed envelope (box) and clearly marked, "EUPISD Maintenance Truck Bid". The School District requests one signed proposal.
