



SPECIAL EDUCATION SUMMARY DATA (EXECUTIVE DIRECTOR)

PURPOSE:

The **Special Education Summary Data** report is created to assist the Executive Director with managing the Vertical Team's ability to ensure campuses meet 100% compliance for timely development and implementation of the ARD/IEP. ARDs must be reviewed and updated annually.

The report is divided into four sections.

SECTION I – PEIMS Monthly Summary:

The data displays past due events and upcoming events due the next month. If all ARDs are not held by their due date in the special education case management system, they will be out of compliance.

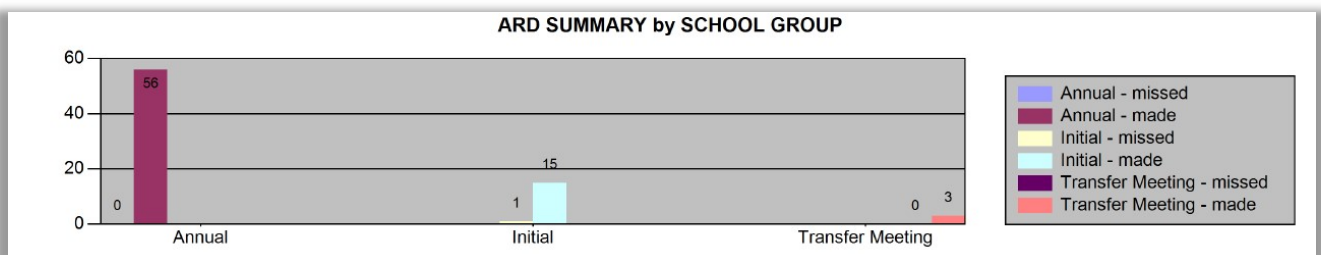

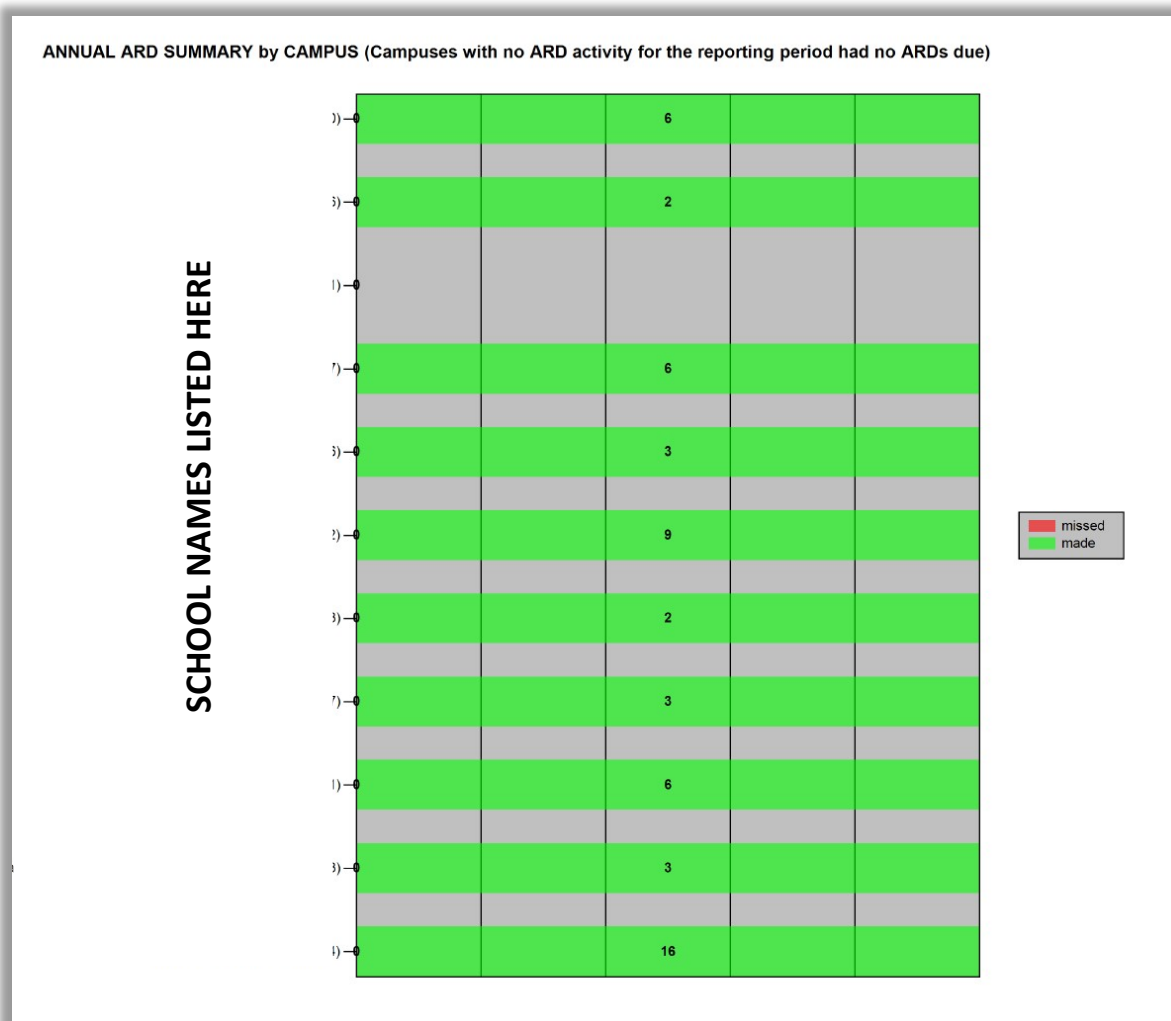

The bar graph illustrates the number of referrals to special education by month within the past year for the feeder.

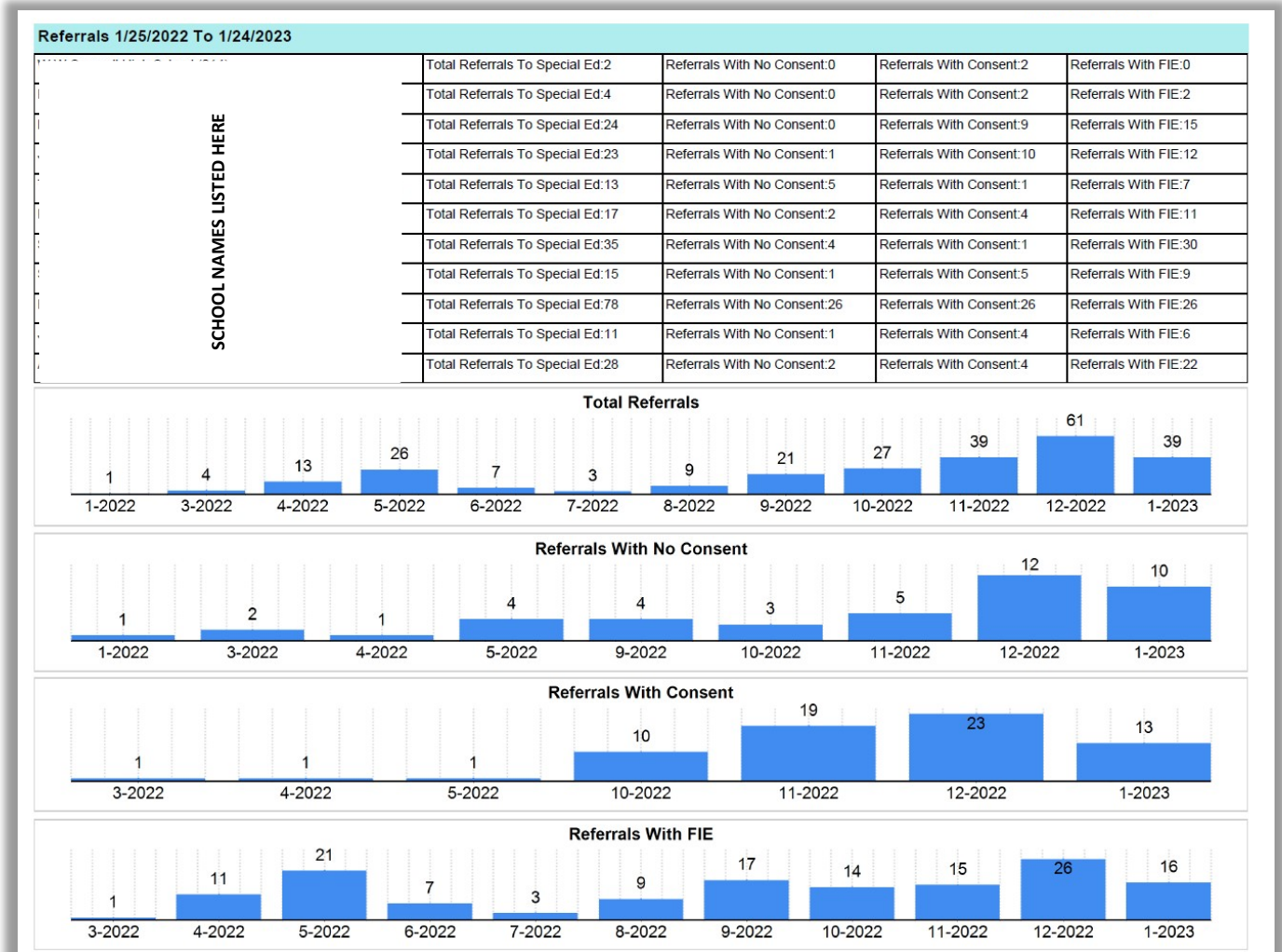

The example shows the number of parent consents required within the date range. The first campus has 0 parent consents required from the 2 referrals made

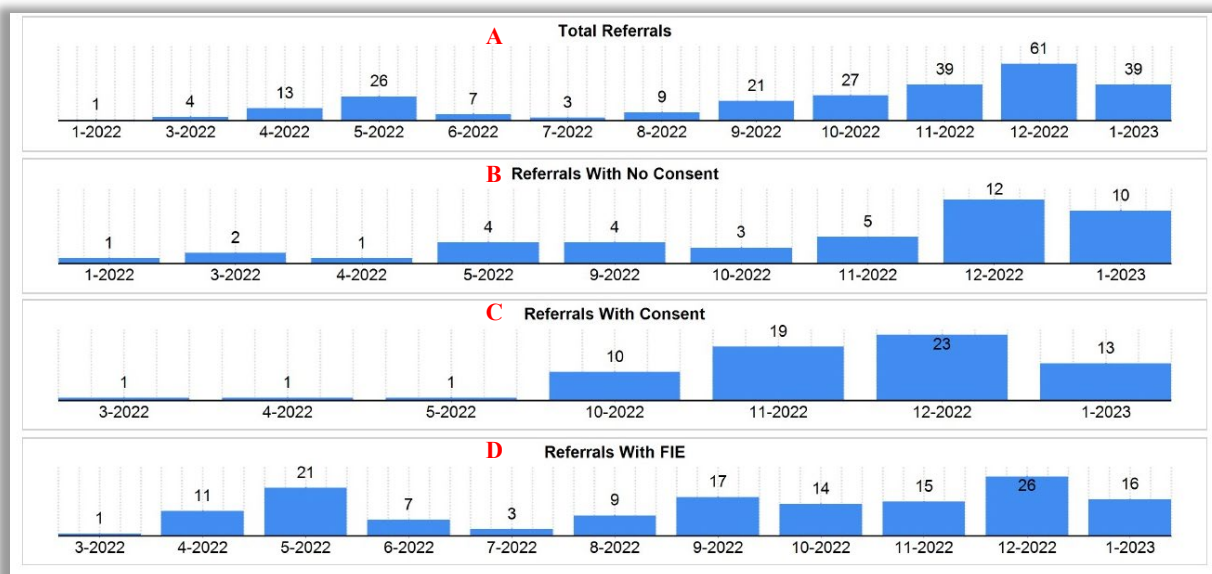
D. Referrals with Consent – Total number of referrals made for a special education evaluation whereas the parent consent has been obtained for the specified date range

The example shows the first campus has obtained two parent consents for the two referrals made

E. Referrals with FIE – Total number of referrals made for a special education evaluation whereas the evaluation process has been completed

The example shows the first campus has 0 FIEs completed for the 2 referrals made

A. Total Referrals – Total number of referrals per month

The example shows the referrals made by campuses in the feeder within the specified date range. One referral in 01/2022, 9 referrals in 8/2022, 61 referrals in 12/2022, etc.

B. Referrals With No Consent – Total number of referrals made for a special education evaluation in the feeder requiring a parent consent within the specified date range

The example shows 42 parent consents are required from the 250 referrals made within the date range – one parent consent is required from 01/2022 referrals, 12 parent consents are required from 12/2022 referrals, etc.

C. Referrals With Consent – Total number of referrals made for a special education evaluation whereas the parent consent has been obtained for the specified date range

The example shows 68 parent consents have been obtained for the specified date range – one parent consent from referrals in 03/2022, 12 parent consents from referrals in 10/2022, 23 parent consents from referrals in 12/2022, etc.

D. Referrals With FIE – Total number of referrals made for a special education evaluation whereas the evaluation process has been completed

The example shows 167 referrals made for a special education evaluation have been completed within the specified date range. The students may or may not have had their Initial ARD/IEP meeting completed – one referral from 03/2022, 9 referrals from 08/2022, 26 referrals from 12/2022, etc.

SECTION IV – Progress Monitoring

This section identifies the objectives that are being monitored. At least one score has to be documented for the objective to be counted as being monitored.
