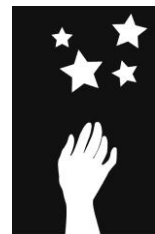

### Scholarship History:

This scholarship was created in 2016 by the family of Michaela Rose Duvall, a Davenport Central High School alumnus who passed away in May 2015. The scholarship will be awarded to an individual who best represents Michaela's devotion to academics and athletics.

**Eligibility:** Applicants must have graduated from Davenport Central High School by the last day of June while maintaining an overall GPA of at least 2.8 OR an ACT of 20 or higher. Applicants must have participated in athletics for all four years of high school with plans to participate in intercollegiate athletics. Special consideration is given to Track & Field athletes.

**Requirements:** Applicants must provide a letter of recommendation from a teacher, administrator, coach, or counselor, who is not a member of the Duvall Scholarship selection committee. A current transcript of grades is also required. Applicants must also include an essay (500 words max) explaining their college plans and life goals.

### Deadline & Application:

Application deadline is March 1, on or before 11:59 P.M.

**Award:** This endowed scholarship provides one (1) scholarship of up to \$500 one-time award.

If awarded this scholarship a verification of enrollment (Student Information Form) must be submitted to the Davenport Schools Foundation office by **June 1**. Failure to submit the Student Information Form may forfeit an award. Award funds will be distributed to the institution of enrollment in August.
