

With Option to Renew for Second and Third Year

This contract is made November 30, 2024 between Norris Insurance Consultants, Inc. and the client listed next and in consideration of the charges shown:

The work to be performed for the ST. MARY PARISH SCHOOL BOARD (referred to as BOARD) by Norris Insurance Consultants, Inc. (referred to as NORRIS) will be governed by the following terms:

- CONTRACT TERM: This contract is for a one-year term commencing on the date shown above. It will automatically
 renew for a second year on 11-30-25 and for a third year on 11-30-26 unless either party gives written notice to the
 other prior to either of those dates of its intent not to renew. Non-renewal carries no penalty nor is cause required.
 The fee for each renewal shall be the fee shown above.
- 2. WORK: NORRIS will provide the BOARD advice and assistance for certain types of insurance the BOARD purchases such as: (a) Review and manage renewal of these policy types; General Liability, Automobile, Workers Compensation, Umbrella, School Board Errors & Omissions, Crime, Building & Contents, Computers, Band Instruments, Flood, Boiler & Machinery and Student Accident; (b) review exposure to loss; (c) recommend changes in insurance protection, retention or deductible; (d) develop calendar of events for managing competitive quotes; (e) in conjunction with board or staff, develop list of agents who will participate; (f) develop insurance specification write REQUEST FOR PROPOSALS (RFP); (g) conduct agent meetings to review RFP and assign carriers; (h) conduct opening of competitive quotes; (i) prepare spreadsheet of quotes and present to board; (j) once board vote decides award, issue award letter to agent(s); (k) review binders to verify conformity to quote; (l) review policies when received to verify conformity to quote; (m) provide stand-by or telephone support for insurance problems that might arise during contract year.

DECLARATION OF VACANCY IN POSITION OF SCHOOL BOARD MEMBER, DISTRICT 7, ST. MARY PARISH SCHOOL BOARD AND PROCLAMATION CALLING SPECIAL ELECTION TO FILL SUCH VACANCY

WHEREAS, due to the resignation of Honorable Murphy Pontiff, Jr. on September 30, 2024, a vacancy now exists in the office of School Board Member, District 7, St. Mary Parish School Board; and

WHEREAS, Louisiana Revised Statute 18:602 requires that the St. Mary Parish School Board formally declare the vacancy in its membership and appoint an individual to fill the vacancy until a special election can be conducted in accordance with the requirements of law.

NOW, THEREFORE, BE IT DULY RESOLVED that the St. Mary Parish School Board does hereby order and direct as follows:

- SECTION 1: The School Board hereby declares that, due to the resignation of Honorable Murphy Pontiff, Jr., the office of School Board Member, District 7, St. Mary Parish School Board, is vacant.
- SECTION 2: A special election shall be held for the purpose of electing a qualified individual to fill the vacancy in the office of School Board Member, District 7, St. Mary Parish School Board.
- SECTION 3: Any qualified person desiring to become a candidate for the office shall file a notice of candidacy, accompanied by a qualifying fee or a nominating petition, as required or authorized by law, with the appropriate election official in the manner and form and under the procedures and conditions set forth in the Louisiana Election Code during the period commencing Wednesday, January 29, 2025 and ending at 4:30 p.m. on Friday, January 31, 2025.
- **SECTION 4:** The special election shall be held and conducted under the applicable provisions of the Louisiana Election Code.
- SECTION 5: The primary election shall be held March 29, 2025, and the general election, if necessary, shall be held May 3, 2025, at the times and places and in the manner prescribed by law.

SECTION 6: The Secretary of State, Commissioner of Elections, Parish Board of Election Supervisors, Clerk of Court, Registrar of Voters, and all other persons charged with any power, function, right, duty or responsibility in conducting elections in the jurisdiction of the vacant position described herein are hereby authorized, requested, directed and empowered to exercise every lawful function and to do every act necessary to conduct the special election, to cause the returns to be made, to canvass and promulgate the results, and to perform all related and incidental functions.

SECTION 7: Superintendent Buffy S. Fegenbush (or her designee) will take all action necessary to immediately publish this proclamation in the School Board's official journal.

Section 8: Superintendent Buffy S. Fegenbush (or her designee) will send a copy of this proclamation to the Clerk of Court for the 16th Judicial District and to the Secretary of State by registered or certified mail no later than twenty-four (24) hours after this proclamation is issued.

Dear Members of the Board, Dr. Fegenbush, and Staff Respectively:

It is my distinct pleasure to introduce myself to this body. For those of you who may not know me, I am Carla B. Pellerin or simply Carla. I am native to St. Mary Parish, born in Franklin, raised by two dedicated citizens of the parish, the late Harold and Edwina Broussard. I am married to Brian Pellerin, and we have one son, Tyreek, who is a 2022 graduate of Centerville High School.

Briefly regarding my family upbringing, my dad was a dedicated school bus driver for years, his last route was the one to USL in the mid-to late 80's, transporting local students to facilitate access to higher education. My mom was a HeadStart pioneer, she was in the first wave of teachers and retired as a center coordinator. I was a first generation HeadStart student. I graduated from Franklin Senior High School in 1985. I went onto USL (now ULL) graduated in Mass Communications in the Spring of 1991. My mass communications experience went all the way back to high school when I worked as a radio disc jockey at KFRA in Franklin. During undergrad, I interned and was subsequently hired as a morning show producer and field reporter at KATC TV-3, one of my last field assignments was Hurricane Andrew aftermath coverage. Shortly after that event, I found myself shifting my focus and energy toward a local non-profit where my role evolved and blossomed into a new career in public and community health centers which began at the Teche Action Clinic (1994). It was during this season that I enrolled in an executive program at Tulane University and received my master's in health administration. The invaluable experience at Teche Action prepared me to spread my wings as far out as eastern North Carolina for a few years to head up a community health center in a town called Kinston (2007). It was during these years that I learned about Board service, in two roles one as chief executive to the health center board, and as a board member of the statewide primary care association. After my parents began to decline in age and health, I returned home, and soon thereafter took on a new role as administrator of the Fairview Treatment Center (2013), which was part of parish government, Fairview is now part of a private, non-profit behavioral health delivery system. While at Fairview, I was nominated to participate in the St. Mary Parish Chamber of Commerce's Leadership Class. We were the only class that began in 2020 but did not conclude until the following year due to the pandemic. After my time at Fairview ended, I moved onto a program that is operated by the Catholic Charities division of the Houma-Thibodeaux Diocese. I currently serve as the administrator of the Assisi Bridge

House which serves men in recovery. I am also a counselor in training (CIT) which means I have a provisional license in addictions counseling. I've spent the last 11 years of my career in this field.

Now that I've introduced myself, I am writing this letter of interest because I have been approached about the district seven school board seat more than once. As of this day, I am officially declaring my interest in serving on the Board. I believe that I have a broad knowledge base, I am open to learning and expanding that base. I believe all of you, the board and the staff, play a critical role in the overall health and wellbeing of our community. I have always been mission-driven, and I believe in the importance of service above self. I have fueled this belief in my work and career. Serving on the St. Mary Parish School Board would be an honor and a duty that I would fully embrace should I be initially nominated to serve by the board and later by the constituents in my district.


