### Superintendent's Highlights

The Douglas County School District is the 7th largest school district in Nevada with an enrollment of approximately 5000 students. DCSD consists of 14 schools in the communities of Gardnerville, Minden, and South Lake Tahoe, Nevada in the beautiful Carson Valley and Lake Tahoe Regions.

We are proud of our students, staff, parents and community for their dedication in meeting the needs of all students. We continue to be excited about our work district-wide with EPIC Learning. As a district, we are committed to modernizing classroom instruction and personalizing student learning. Our EPIC Instructional Model includes 3 pillars: Positive Culture, Learner Centered, and Responsible Instruction. Our goal is to develop students who are problem finders who struggle and fail forward in their quest to grow through risk-taking, collaboration and reflection. Our staff assess continually to respond and adapt—creating individuals and authentic learning. And finally, with integrity, we promote empathy, compassion and respect affirming our commitment to making a positive difference in the lives of our learners.

As part of our EPIC Learning movement, Douglas County School District has also developed a "Portrait of a Learner", which outlines the attributes we expect all DCSD learners to possess. In DCSD, our students are EPIC learners who demonstrate the following: 1) Empowered set goals, create opportunities, try new experiences for meaningful learning, have high self-efficacy, understand the importance of trusting teammates, have the skills and know-how to take on worthy challenges and goals and have a growth mindset that allows from learning from mistakes, 2) Prepared Learners possess the tools and perseverance to be critical thinkers, are motivated to take the next step in their journey, are open to new ideas and are willing to embrace new experiences while being ready to be uncomfortable, 3) Inspired learners are passionate to discover challenges and are open to new ideas and problem-solving while working with mentors and learning new ideas from their peers to make the world a better place, and 4) Connected Learners share thinking and common goals and learn more about others through conversation while developing relationships beyond the school environment.

DCSD also values our relationship with our families and communities. We encourage visitation to our schools and for all stakeholders to play an active role in the education of our students. As a collaborative effort, we know that all DCSD students will be successful both now and in their future.

As a district, we are proud of the following accomplishments:

1. Melissa Wood, English Language Learner teacher at Douglas High School School, was named the 2024 High School

Personalized Learning Classroom of the Year and Becky Goins, Kindergarten Teacher at Jacks Valley Elementary School was named 2024 Primary Personalized Classroom of the Year.

2. Niche.com ranked DCSD as the 2023 #1 school district in the state of Nevada.
3. U.S. News & World Reports ranked George Whittell High School as the 9th, and Douglas High School as the 10th best out of 111 traditional high schools in the state of Nevada.
4. Douglas County School District issued a 183% increase in College & Career Ready diplomas.
5. DCSD has launched an extensive marketing campaign that included the hiring of a Director of Marketing & Communications, the development of new websites, a district-wide rebranding, and the development of promotional materials to enhance staff and family recruitment.
6. Achieved a Stage 6 of 7 in the implementation of EPIC Learning through Modern Teacher.
7. We continue to focus on the safety of our students and staff through our partnership with the Douglas County Sheriff's Office that provides four (4) school resource officers to our schools.
8. A commitment to the professional and leadership development of our employees through an induction program for all new certified staff, a Leadership Academy for current and aspiring administrators, and PD for all employees through our district professional development center and EPIC Learning Instructional Coaches.
9. A commitment to open and accessible communication with our school community through biannual site communications meetings, bi-monthly employee group meetings, and community town hall meetings with the superintendent and executive staff, along with an increased presence on social media platforms, and sending out a monthly district newsletter highlighting staff accomplishments, student achievements, important news, and upcoming dates.
10. Launched a district app that has everything parents and staff need to stay informed at their fingertips.
11. Hosted free mental health webinars and free one-on-one parent coaching sessions for DCSD families through Parent Guidance on various topics, including Helping Your Child Succeed – Three Parenting Styles, De-escalating Cycles of Conflict, Establishing Healthy Boundaries, School Avoidance, How to Motivate Your Child, Supporting Your Child After Trauma, Understanding Video Game Addiction, Parenting through Anxiety and Depression, and Positive Body Image and Positive Language.
12. Four of our schools participated in the hydroponic program by Green Our Planet, with three schools taking part in the Giant Student Farmers Market in Carson City.
13. Douglas High School had a student awarded a National Merit Scholarship this year.
14. Jacks Valley Elementary School completed two semesters of the pilot Explorations program, offering 26 diverse, hands-on courses. This initiative has become integral to JVES's culture, with sessions on Mondays from 1:30-3:00 PM, and plans to extend to other elementary schools.
15. Obtained a \$132,000 grant to launch a fire science program at George Whittell High School for the 2024-2025 school year.
16. We fostered cross-grade level collaboration through buddy programs, where elementary schools teamed up with secondary schools. For example, ASPIRE High School hosted Minden Elementary's third graders for themed activity days, enriching their experience with creativity and fun. Meanwhile, first and second graders from C.C. Meneley Elementary collaborated with Pau-Wa-Lu Middle School students to bring hand-drawn monsters to life through clay sculptures and storytelling, promoting creativity, leadership, and teamwork.

School safety is a priority in Douglas County Schools. All educational stakeholders work together to create school climates which are inviting, supportive and hold high expectations for appropriate behavior. Site principals work with their Multi-Tiered System of Support Team to align expectations and corrective actions across the system. ## Technology

Online Curriculum/Platforms, especially those that use Single-Sign-On

The technology team partners with Curriculum Director Shannon Brown to ensure that online platforms are approved for use and ensure safety. Our online filter/firewall service is a bundle of multiple software packages, which include tools that allow instructors to monitor student screens, block individual sites, etc.

Chromebooks

The technology department ensures that Chromebooks (all students use Chromebooks; and some use PCs in computer labs) are current and receive automatic updates and that 700+ Chromebooks are repaired or replaced when broken over the course of the last school year.

Supporting Computer Based Testing (which essentially provides data that is used to drive instruction)

The technology department ensures that the Chromebooks deployed throughout the district have current Kiosk-mode, test specific applications; and these tests, such as WIDA are used for data collection by the state. Other tests include ACT, AP testing, and so on. The curriculum department and the school district administration closely look at these types of tests results and work with the technology team on initiatives throughout the school year (such as online platforms to purchase or discontinue utilizing).

Classroom Technology; interactive touch panels, document cameras, etc.

The district has a vast majority of classrooms with interactive touchscreens, whether they are our new-model Newline panels or Promethean boards. According to experts, "...Students are working with tablets and laptops as early as kindergarten in today's education environment. Very young students can improve their fine motor skills with touch-screen devices. Studies have shown that interacting with screens through scrolling can improve these skills." - [https://edtechmagazine.com/k12/article/2022/08/make-learning-engaging-and-interactive-touch-screen-devices\(edtechmagazine.com\)](https://edtechmagazine.com/k12/article/2022/08/make-learning-engaging-and-interactive-touch-screen-devices(edtechmagazine.com)). Every teacher also has their own document camera (that was issued during COVID-times).

Constant upgrades/maintenance to DCSD's technology infrastructure

The technology department has been working on behind the scenes projects to ensure that in-class education runs smoothly; namely network switch upgrades, bell system/emergency system upgrades, wireless access point upgrades, as well as instructor workstation/laptop upgrades.

Infinite Campus' Student and Parent Portals

Parents and students both utilize Infinite Campus' student and parent portal, which provide essential information regarding students' progress and needs. The technology department's staff includes a Student Information Systems Specialist who is one of the administrators of that platform. Students and parents tracking individual student grades in real-time is an effective tool, and encompasses all of DCSD's efforts towards instruction as well as the student's efforts in their own work.

DCSD's ticketing system; keeping track of teachers' technology issues needs

The technology department utilizes KACE to track technology tickets. When teachers' needs are met, more time can be spent on focusing on instructional items. Sometimes tickets range from an issue from wi-fi issues, device issues, or log-in problems; but whatever the case is, the technology team works to solve those concerns and allows teachers to get back on track asap.

Inclusive Education

The inclusive education department utilizes technology to meet the needs of students throughout the district to meet the requirements of individual students' IEPs. This may range from specialty devices, such as iPads and specialty software. Specialists work with these students and track their progress. The technology department supports these types of devices, such as the iPads and also the software that is installed on them, utilizing a MultiMedia Device Management (MDM) tool called JAMF.

Random examples of Technology needs addressed by the Technology Department

- We brought over a larger computer monitor for a student who has reduced vision.
- We purchased a Samsung Tablet with the Google Translate app for an elementary student who came from Ukraine and did not speak English
- We purchased an iPad and configured it for PWL middle school so for one of their classes they could use it for recording news videos for one of their classes
- We delivered a 3-D printer to the PWL middle school library, as students in various classes were interested utilizing it

## Curriculum Details

The Douglas County School Board of Trustees recognizes the responsibility for the quality of the educational program of the

schools in Douglas County School District and directs the district curriculum and assessments be evaluated, adapted, developed and revised on a continuing basis to ensure a rigorous academic experience for all students. The standards, curriculum, and assessments of the Douglas County School District are to remain consistent with the written Strategic Plan Goals and objectives. They are designed to develop individual talents and interests and provide for continuous learning through effective articulation and encourage the utilization of community resources.

The Douglas County School District standard core academic curriculum consists of English language arts, mathematics, science, social studies, and computer science. Curricular and instructional support is also provided in the areas of technology, fine arts, career and technical education, world languages, health, and physical education providing students with a well-rounded, full curriculum. The foundation of the curriculum in Douglas County School District is on Nevada Academic Content Standards in all content areas. Curriculum documents are currently in various states of development to reflect the ongoing revisions for each grade level and subject area based upon state standards. Each content area is systematically reviewed and revised as needed to align with the rigor demanded by the Nevada Academic Content Standards.

- Educational opportunities for academically talented students

- Kindergarten through 5th grade District-wide common assessments in ELA and Math

The Douglas County School District has adopted a literacy plan which addresses literacy instruction from birth to graduation. At the heart of literacy instruction is the strong-held belief that all students can become independent readers and writers. Douglas County School District's commitment to literacy begins before kindergarten and offers support for students in all content areas through their senior year of high school. The Nevada Academic Content Standards provide the framework for "what" students need to be able to demonstrate and the Douglas County School District Literacy Plan explains "how" the teachers will ensure instruction meets the needs of all students. Teachers in the Douglas County School District are expected to follow a balanced literacy approach to literacy instruction that is rooted in years of research across all grade levels and all content areas.

Student progress toward achievement is continually assessed in a variety of ways. Teachers are expected to use a wide range of data and student benchmark expectations to determine appropriate interventions when differentiating instruction, providing remediation, and extending learning opportunities for our students. Additional learning opportunities for students include summer school, alternative education, on-line course work and site tutoring to provide enrichment and remediation opportunities.
