Dear Alumni and Friends,

Our 161st school year is underway, and it is the first time my team has begun the year in Ryken Hall. While I am sure that Theodore Ryken's humility was more pronounced in his day compared to the many traits



of the school's current culture, I am also sure that his zeal to do his very best for his students every day aligns precisely with what we are striving for today. As a reminder, I am happy to share some real-time examples of these efforts.

Faith: The Xaverian Brothers have always referenced "falling in love with the service of God" and worked with our students and faculty to ensure that this notion is understood and cultivated within the school community. Each young man's faith journey takes a unique path. The ability to tie this journey together occurs during the Christian Awakening Retreat, offered to juniors and

seniors. Faculty and retreat leaders always marvel at how well this program solidifies students' faith and love for one another, and parents witness their transformation at the retreat closing.

Academics: Of course, we can compare the St. X academic program to other local, regional, or national schools in many ways. One of those benchmarks is the National Merit Program. Just recently announced, fifteen of our young men were named semifinalists, and another seven were named commended students. It has been a decade since our school has produced such a significant number. This is a direct testament to the St. X faculty, who do so much to foster and develop critical thinking skills in their students.

Service: Spirit Week is a time of excitement and celebration, but we also see it as an opportunity to embody the values of compassion and humility. At the beginning of Spirit Week, our boys, alongside students from Trinity, Assumption, and Sacred Heart, united to honor the memory of indigent and homeless individuals by locating 40 grave sites and placing headstones. Additionally, our entire school community set a goal to collect 4,000 pounds of food for the Dare to Care Food Bank, turning school spirit into meaningful action and being good shepherds of the Lord.

Following His Calling

Do you know the last time that someone from the United States became a Xaverian Brother? It was 50 years ago. God willing, that is going to change! Class of 2024 graduate Angelo Centeno found his calling. Growing up, his Catholic education began in fifth grade, and then he made the decision to attend St. X. Throughout his life, Angelo has been fascinated by languages, cultural norms, and the ability "to exchange knowledge." Those are some of the things that inspired him to consider missionary work. Angelo is also conversational in Arabic, Spanish, and Kiswahili.

This past summer, Angelo spent time in Bungoma, Kenya, with the Xaverian Brothers and "realized that the possibility of becoming a brother was still alive." To summarize his experience, he noted, "I felt a sense of community and love that I had never known before. Being around so many men who shared my values and joy has been the motivating force behind my decision to becoming a Xaverian. While at St. X, I felt a strong desire to serve and 'fell in love with the service of God,' as quoted by Theodore James Ryken in the Fundamental Principles of the Brothers of Saint Francis Xavier. For all these reasons and so many more, I have felt a call to religious life with the Xaverian Brothers."



While following his passion to serve, Angelo is double majoring at Thomas More University in theology and education. After completing his studies, he plans to move to Kenya to begin the candidacy. Angelo explained that in Kenya he became an "aspiring brother," meaning he is aspiring to join the Brotherhood. He outlined his next steps after graduation: move to Kenya and join the candidacy for 3–6 months, spend a year in discernment as a postulant, and start his one-year novitiate experience before professing his first vows.

Regarding his time at St. X, Angelo shared that his favorite memory was the Christian Awakening Retreat. He offered, "I learned so much about myself and met so many wonderful people and developed a stronger relationship with Christ and the Church. It was there that I met my now-Godfather, Zach Blincoe '24."

Angelo loved so many of his teachers but specifically mentioned Mrs. Karen White and Coach John Jefferson. He stated about Mrs. White, his sophomore theology teacher, that "her passion for inclusivity of all people was most inspiring, and it taught me what it meant to be a true Christian." Additionally, he said, "Coach J embodied the Xaverian Charism. Although I only had him in class for a short time, he inspired me to be more. This has given me the ability to assist others in realizing their own gifts and motivate them to be better as well."

For St. X freshmen, Angelo gave the following advice, "Don't let your first lousy grade define you. Instead, practice being an autonomous individual."

Let us pray for Angelo as he continues his faith journey.

Grads Reconnect at Growing BrightSpring

Countless success stories in the business world intertwine multiple Tiger alumni, the experiences they shared at St. X, and the continued connectivity to the school community. Another example to share with you is the story of 1997 classmates Jim Mattingly and John Thomas. The two have been crunching numbers for years at BrightSpring Health Services, which is among the fastest-growing companies of scale in healthcare.

Jim and John first connected in Joe Bergamini's accounting class during their time at St. X. They continued their studies at Bellarmine University, with Jim studying Economics and John pursuing Accounting. Following graduation, their initial career paths took them in different directions. In 2018, they reconnected when John joined BrightSpring Health Services as the Corporate Controller. Jim was, and remains, BrightSpring's Chief Financial Officer.

Together at BrightSpring, they play a critical role while the company experiences exponential expansion from organic growth along with over 50 strategic acquisitions through 2023. Before the initial public offering in January of this year, it was by far Kentucky's largest private company. BrightSpring is now traded on the NASDAQ Stock Exchange under the symbol "BTSG," with more than \$8.8 billion in revenue in 2023. At the time of this interview, BrightSpring had just completed its seventh acquisition of 2024 — North Central Florida Hospice Inc. and Haven Medical Group LLC.

BrightSpring Health Services began nearly 50 years ago as ResCare, Inc. in Louisville and merged with Louisville-based PharMerica in 2019. Its family of brands provides services that impact more than 400,000 customers, clients, and patients daily. Jim explained, "Our complementary, high-quality services for high-need patients and clients, including supportive care and clinical and pharmacy solutions, set us apart. Our services focus on improving outcomes and reducing costs while serving patients nationwide in their preferred setting – their homes and communities."

When discussing how his St. X experiences prepared him for such a noteworthy career path, Jim shared that "being surrounded by intelligent and driven students and being guided by experienced and strong faculty raised my expectations and uncovered a competitive drive that I didn't know existed."

He also cited the importance of learning to work as a team with humility and to "surround yourself with great people and seek out people with different experiences than you, to complement what you bring to the table."

John noted that the experience St. X provides is crucial to laying a great foundation to allow young men to accomplish anything they want to in life and their careers.

A St. X education also extends far beyond the classroom. Jim highlighted the Christian Awakening Retreat as a "pivotal moment." He added, "Retreat was a time to really explore who I was and who I wanted to be, what my personal values were and, what I stood for."

Jim and John mentioned taking advantage of the extensive alumni network in their current roles as Executive Vice President and CFO, and Vice President, Controller, respectively. Jim commented, "Many of our banking and vendor partners are St. X-affiliated. And those relationships are important. They immediately convey a level of professionalism and a shared sense of values – personal, spiritual, work ethic, and drive to perform." John affirmed, "The brotherhood developed at St. X leads to a very strong connection with any fellow alumni that continues well beyond the high school years."

The St. X connection is alive and well among the more than 1,000 local employees at BrightSpring. Jim acknowledged that there are dozens of other graduates and spouses of graduates on the payroll. He added that the company's Chief Executive Officer, Jon Rousseau, and Chief Human Resources Officer, Lisa Nalley, each have sons at St. X.

Jim and John look forward to next August when their sons continue the tradition at St. X when they enter as freshmen.





A New Tradition with Class Ties

Traditions are an important part of the high school experience, and St. X has indulged students and alumni with them for more than 100 years. Traditions foster unity and create lasting memories. The newest St. X tradition began during Freshman Orientation with the distribution of Class of 2028 ties. Members of the senior class had the prestigious honor of gifting all freshmen with a custom class tie to acknowledge the new bonds between the students,

the school, and their classmates. These "ties that bind us" are not just accessories. They symbolize the shared experiences, challenges, milestones, and memories the students will create together. Freshmen are asked to wear their ties at key events throughout their time at St. X and especially at all-school liturgies.

Student's Coding Produces Real-Time Results

Last year, as a junior rower on the inaugural Crew team, Colin Heskins identified a need to improve the sharing of rowing machine statistics. With workouts on rowing machines (ergs), real-time statistics would not only quickly measure the progress of the team, but also better motivate his teammates.

Head Coach Chet Riley, a varsity heavyweight crew

coxswain for the United States Naval Academy, was already aware of the importance of collecting and maintaining team statistics. He had been manually recording the erg stats from the four-days-a-week workouts, noting "the key measure of progress comes from the team's ability to get faster and go harder on the erg."

Colin, who had spent some time learning Python coding language and was enrolled in a St. X coding course last year, approached Mr. Brad Derrick '99 about writing a program to achieve the results he wanted. With the encouragement of his teacher and Coach Riley, Colin wrote the code for a program that would save the workouts from the rowing machine to a Google sheet using the Concept2 Application Program Interface (API). Concept2 Logbook is the app associated with the erg. Colin tested his prototype, and it was successful.

Coach Riley applauded Colin's work and had him train the team on how to set up the application so all rowing data could be captured. "From the data that we gathered, we were able to develop reporting in a much more automated way and provide almost immediate feedback for the rowers on their progress. And not only that, it decreased the amount of time that our coaches spent collecting and managing data from several hours per week to just a couple minutes a day. It was a huge win for us."

St. X is proud to announce a new role for longtime faculty member and coach Mike Glaser '70 that specifically enhances the student experience at St. X. The Director of Student Activities position emphasizes celebrating the diverse

achievements of all students, fostering togetherness, and reinforcing the Xaverian Brothers' core values through coordinated activities. By promoting recognition and setting high standards, the goal is to ensure that every student feels valued and included in the school community. Glaser's mission is to remind students that success is about focusing on the "little things," doing one's best, and upholding the St. X way in every aspect of school life.

Glaser brings a wealth of experience and dedication to this full-time position. Having spent nearly six decades at St. X, as a student, coach, and member of the English faculty, he exudes a contagious enthusiasm for the Green and Gold that has contributed significantly to his legacy. Glaser's deep-rooted connection to St. X and his ability to inspire and uplift students, makes him the perfect leader to celebrate student success, foster unity, and promote involvement across all activities!

Glaser was inducted into the St. X Alumni Hall of Honors in 1996 and the Kentucky High School Athletic Association Hall of Fame in 2022.

Academic Accomplishments




The National Merit Scholarship Corporation recognized 22 seniors for their performance on the Preliminary SAT/National Merit Scholarship Qualifying Test. Congratulations to our 15 National Merit Semifinalists and seven Commended Students.

Saint Xavier's Class of 2025 features an exceptional group of academic talent. We are excited to announce that the National Merit Scholarship Corporation recognized 15 seniors as National Merit Semifinalists. This group represents the top one percent of U.S. high school seniors and is the school's highest number of semifinalists since 2013, when St. X boasted 22. Congratulations to Ben Blackford, Alexander Craddock, Jackson Duthie, Beckett Galloway, Rocco Gandolfo, Chadwick McTighe, Jackson Price, John Rousseau, Whit Ruml, William Spohn, Lincoln Staab, Mason Steele, Alex Thiesing, Hayden Vermost, and Patrick Wright. Furthermore, an additional seven

seniors were named Commended Students by the National Merit Scholarship Corporation. Kudos to Hobs Ashburner, Joshua Clark, Colin Heskins, Albert Hulbert, Henry-James Schmidt, Sam Shewmaker, and John Waskey. While Commended Students do not continue in the competition for National Merit Scholarships, they can become candidates for special scholarships sponsored by corporations and businesses.

In other news, the College Board announced our remarkable success on Advanced Placement Program Exams administered this past May. St. X had 278 students take a total of 705 tests, and 89 percent passed (global average was 68 percent) with a score of 3 or higher. Of the 278 test takers, 136 received noteworthy distinction from the College Board (see graphic on this page). First and foremost, 66 students were designated AP Scholars with Distinction for achieving an average score of at least 3.5 on all AP Exams taken and scores of 3 or higher on five or more of these exams. The distinction of AP Scholars with Honor was granted to 27 test takers for achieving an average score of at least 3.25 on all AP Exams taken and scores of 3 or higher on four or more of these exams. Also, the College Board recognized 43 test takers as AP Scholars for scoring at least 3 or higher on three or more AP Exams.

Lastly, the senior class has produced three perfect ACT scores from Hobs Ashburner, Graham Brown, and Whit Ruml. St. X claims 30 Tigers in the last 13 years who achieved a score of 36. Congratulations to all our young men achieving national recognition.

St. X is named a National Blue Ribbon School for the fifth time by the U.S. Department of Education. The school is one of 40 private schools nationwide to be named a 2023 National Blue Ribbon School and the only private high school in Kentucky to achieve this significant honor. As of 2023, we are one of three private high schools in the country and the only private high school in the state to receive the distinction five times.

National Blue Ribbon Schools serve as models of effective school practices for state and district educators and other schools throughout the nation. St. X was one of 353 schools recognized in 2023 for overall academic performance and progress in closing achievement gaps among student groups on assessments.





During the 2023-2024 fiscal year, Saint Xavier remained within the parameters of the budget and finished the fiscal year securely in the black.

Renaissance Man: Embracing the Evolution of Media



Hunter S. Thompson famously wrote in his classic, Fear and Loathing in Las Vegas, "Buy the ticket, take the ride." Stephen George, Class of 1999 and CEO of Louisville Public Media, has committed to taking the ride, living a life rich in experience and hard work.

Crediting Thompson and Gonzo Journalism for inspiring his early foray into journalism, another experience that piqued Stephen's journalistic appetite occurred when he rewrote Shakespeare's Macbeth as an

assignment in Linda Winkler's English class. According to Stephen, "This was perhaps the first time I was told I was good at writing, which gave me the confidence to pursue it with passion moving forward." But writing was not Stephen's only passion, and in addition to working for the St. X school paper as a journalist, Stephen was a musician, playing in several bands and touring well beyond his time at St. X.

Enter the Renaissance Man, as Stephen was aptly coined by colleague and mentor, former U.S. Rep. John Yarmuth. Yarmuth was instrumental during Stephen's career, helping him get his start at LEO, which he eventually ran, while still a student at the University of Louisville. "It was evident immediately that Stephen was a very bright person with numerous talents", said Yarmuth. "Stephen worked for me during his career in three different capacities, all of my choosing – he was just that capable across the board."

After LEO, Stephen's career took an interesting turn, finding him as the Press Secretary for Representative Jim Cooper of Tennessee's 5th Congressional District (Nashville). It was during his time with Cooper on Capitol Hill when Stephen had a fortuitous run-in yet again with Yarmuth. Soon thereafter, Stephen found his way back to working with Yarmuth, except this time as Communications Director for the Congressman.

Stephen was successful in this role, as Yarmuth said: "He was as good as anyone on Capitol Hill." But for Stephen, the ride would continue, and the next stop on his adventure would bring him back to Louisville and back to media. He eventually became Executive Editor at Louisville Public Media, where he ran the newsroom for three years. Despite his success on Capitol Hill, Stephen had recently started a family and was eager to return home to his roots.

It has been during his time at Louisville Public Media that Stephen has come into his own as a leader. One of Stephen's oldest and closest friends is Matt Weir, also St. X Class of '99. While Matt will always remember his bike adventures through Louisville's Highlands neighborhood with Stephen and their crew, he also always knew that Stephen would one day be a leader. "He had it all together from an early age; he was definitely mature beyond his years," said Weir. In addition, Weir summarized Stephen's unique talents, which he attributes to his vast array of experiences, "He represents us, and all of Louisville, because he has so many rich alternative adventures. He promotes and encourages diversity through people, voices and experiences."

As Stephen grew in his role as Executive Editor of Louisville Public Media, there was a shakeup in leadership that would yet again find Stephen at a fork in the road. When the CEO role was vacated in 2018, the LPM Board asked Stephen to be interim CEO, which he hesitantly accepted. He had fallen back in love with fielding and filtering the news for his Louisville community and was not certain he wanted to make the transition. But whether it was duty or curiosity that fueled his fire, Stephen accepted the new position.

After a six-month interim period and national search, Stephen was selected as the permanent CEO in 2018. He immediately began to make pivotal changes.

While Stephen has been successful at the helm of LPM, nearly doubling annual revenue and increasing the average users to over 650,000 per month, it has been his impact on the culture and people of LPM and the Louisville community of which he is most proud. In his first all-hands meeting, Stephen told his staff, "I'm going to say the phrase 'I don't know' more than anyone and it's not only safe, but it's expected." His unique ability to be approachable and accepting, is undoubtedly a huge part of his success. As a testament to the culture created by Stephen, in 2014 Louisville *Business First* ranked LPM among its Best Places to Work in Louisville.

In October, Stephen announced he would be leaving his job as CEO of LPM to begin work at the American Journalism Project, a national venture philanthropy organization that is leading the rebirth and reinvention of local news in communities like ours all around the country. As Head of Emerging Markets, Stephen will lead the expansion of AJP's Local Philanthropy Partnerships program, which works in partnership with local civic, philanthropy, and media leaders to develop ambitious, collaborative local news initiatives that make pivotal interventions in their local news sectors. Over the last four years, this program has resulted in the investment of over \$65 million of new local philanthropic capital into sustainable, high-impact plans to bolster local news ecosystems.

Circling back to Stephen's roots, it is clear that he has embraced each chapter of his journey, maintaining curiosity and



seeking experiences that have given him a worldly point of view he shares through the mission of Louisville Public Media. In fact, Stephen's parting advice for St. X students apprehensive about the impending reality of a career highlights his appreciation of his own personal journey: "Be open to experiences and most importantly, work hard. Don't put pressure on yourself to decide immediately, your time at St. X and later in college, both in and out of the classroom, should be used as a dynamic exploration of your interests and needs."
