Oxnard Middle College

Oxnard Middle College High School officially opened its doors during the summer of 2018. During the 2018-2019 school year, we opened with 38 ninth grade students and we have added 35-50 incoming ninth-graders and transfer students each fall. The 2021-2022 school year was the first year that OMC served all four grade levels. The class of 2022 was our inaugural graduating class with 34 students.

Students at OMCHS are dual-enrolled in high school and college all four years. The high school campus is located on the campus of Oxnard College, which is part of the Ventura County Community College District. During the school day, students are enrolled in a combination of high school and college classes to satisfy OUHSD graduation requirements as well as make progress toward a college degree. Each student works with the counseling staff to create a course sequence toward an AA or AS degree, IGETC (The Intersegmental General Education Transfer Curriculum), or a certain number of units, which they will use after high school to continue in their college and career goals. While students are dual-enrolled, they have access to all of the student services offered through Oxnard College and the Ventura County Community College District.

As high school students, OMCHS griffins have access to the resources and activities of the Oxnard Union High School District. In addition to the high school classes and clubs offered on campus at OMCHS, students can be dual enrolled in special programs offered at the comprehensive high schools like Mariachi, Mock Trial, Pre-Engineering, Global Trade and Logistics, and Robotics. OMCHS students can also participate in sports with their school of residence. However, two of our district's high schools recently changed leagues and due to the current rules of the new league, our students are not allowed to play sports with them.

While in all high school classes at OMCHS, students participate in AVID. Students also receive support in educational technology and college courses through an Academic Enrichment class. OMCHS is a one-to-one laptop school. Each student is provided with a laptop as well as a personal hotspot if needed.

OMCHS aligns our instructional calendar closely with Oxnard College to best meet the needs of our students. Because of this, OMCHS follows a different calendar than the rest of Oxnard Union High School District. We also follow a collegiate semester schedule in our high school classes to align with the college system. All high school and college classes end for the first semester before winter break. In the spring, college ends in late May and high school ends in early June to reflect the 180 high school instructional days.

Students at OMC participate in at least 5 high school classes during 9th and 10th grade and in at least 4 high school classes during 11th and 12th grade at the high school. Additionally, students participate with one college class every semester during 9th grade and at least 2 college classes during the 10th, 11th and 12th grade. OMC students have the option to take summer classes with Oxnard College.

Student Code of Conduct

We expect students to follow our OMCHS acronym:

Scholars

- Students will be responsible for following all established classroom and campus rules. By following the rules, students can be certain that their rights and the rights of others as well as their own safety are honored and protected.
- Students will be respectful toward all faculty, college professors, staff members and business partners and other students.
- Students will be respectful of and responsible for using school equipment (including technology) and facilities in an appropriate manner. Students will refrain from purposeful destruction or theft of another person's or school property. Students and/or their parents are expected to make restitution for lost books or damaged property.
- Students will be punctual and in attendance of all scheduled classes unless excused by a parent or guardian. A phone call made to the school explaining the student's absence is required from the parent or guardian. Parents must make contact with the office before their child can be released during the school day. Students cannot be released to a friend or a neighbor unless they are listed on the emergency card.
- Students will honor school as a place for academic and social learning. Students will refrain from using skateboards, bicycles, while on campus.
- Students will follow all school rules for behavior when traveling to and from school or while involved in an off-campus school activity such as a field trip.
- Students will follow all school rules for behavior when attending assemblies or evening activities and will exhibit appropriate audience skills.
- Students will stay within the campus' designated boundaries during school hours.
- Students follow the <u>Acceptable Use Policy</u> (found at: https://www.oxnardunion.org/acceptable-use-policy/) when using technology.

Academic Honesty Policy

Some students have come to believe that their grade, not their learning is the key to success. As a result, some students have resorted to cheating, copying and other forms of academic dishonesty.

A student is in violation of our school policy on Academic Honesty when (s)he/they participates in any of the following activities, including but not limited to:

- □ Copying other students' answers on a quiz, test, homework assignment or project.
- Supplying the answers to another student. Note: All assignments are considered individual assignments unless specifically stated otherwise by the teacher.
- Securing a copy of a class quiz or test beforehand or taking a quiz or test to pass on to other students.
- Getting answers or questions from students who already took the quiz or test.
- Giving answers or questions to students who will take the quiz or test.
- Copying homework or any class assignments from any source (including the Internet) or allowing another student to copy one's own work.
- Presenting other's work as one's own research or work.
- Having unauthorized test aids and not following test or assignment protocol. Note: Any use of a cell phone during a test may be considered a violation of the academic honesty policy.
- □ When taking a quiz online using another tab to look up answers.

It is the responsibility of the student to avoid any situation or action that may cause teachers to believe that this policy has been violated. The teacher will also determine whether the assignment is minor or major.

Students may be suspended for the following actions:

- Caused, attempted to cause, or threatened to cause physical injury.
- Willfully used force or violence on another person, except in self-defense.
- Possessed, sold or otherwise furnished any firearm, knife, explosive, or other dangerous object.
- Possessed, used, sold, furnished, or been under the influence of any controlled substance, alcohol, or intoxicant.
- Offered, arranged, or negotiated to sell a controlled substance, alcohol or intoxicant and then provided a replica substance.
- Attempted or committed robbery or extortion.
- Attempted or caused damage to school or private property.
- Attempted or stole school or private property.
- Possessed, or used a tobacco product.
- Committed an obscene act or engaged in habitual profanity or vulgarity.
- Possessed, offered, arranged, or negotiated to sell drug paraphernalia.
- Disrupted school activities or willfully defied valid authority.
- Knowingly received stolen school or private property.
- Possessed an imitation firearm.
- Attempted or committed sexual assault or committed a sexual battery.
- Harassed, threatened, or intimidated a student complainant or witness in a school disciplinary matter.
- Unlawfully offered, arranged to sell, negotiated to sell, or sold the prescription drug Soma.
- Engaged in, or attempted to engage in, hazing.
- Engaged in an act of bullying, including but not limited to, bullying by means of an electronic act.
- Aided or abetted in the attempted or infliction of physical injury to another. Committed sexual harassment.
- Attempted, threatened, caused, or participated in hate violence.
- Harassment, threats or intimidation creating an intimidating or hostile educational environment.
- Made terroristic threats against school officials or property.

Students may be expelled for the following actions in accordance with EDUCATION CODE SECTION 48915 - Expulsion

- Causing serious injury to another person, except in self-defense.
- Possession of a knife, or other dangerous object of no reasonable use to the pupil.
- Unlawful possession of any controlled substance except for the first offense for the
 possession of not more than one avoirdupois (by weight) ounce of marijuana, other than
 concentrated cannabis, or the possession of over-the-counter medication for use by the
 pupil for medical purposes or medication prescribed for the pupil by a physician.
- Robbery or extortion.
- Assault or battery on any school employee.

Social Media Guidelines for Students

Oxnard Middle College High School is a 1-to-1 school that is immersed in technology. These social media and technology guidelines are to keep students safe, secure, and help them focus on their education. We strongly believe in the power of technology to teach; however, we want to educate students about online etiquette and how behavior in the digital world can affect the school world.

Technology Acceptable Use Policy

Each year, students and parents must sign the Acceptable Use Policy:

• Students that misuse technology will be disciplined. The Student Acceptable Use Policy contains restrictions on accessing inappropriate material.

Technology resources, including, but not limited to, email, Internet access, school computers and tablets, and the use of personal electronic portable devices on school grounds or at school-sponsored events, are to be used for educational purposes only. Adherence to the Student Acceptable Use Policy (AUP) is required for all students' continued access to these technology resources.

To fulfill the state and federal Internet safety laws, and as the parent or guardian of this student, I understand that access to the Internet at school or school-sponsored events is designed for educational purposes. I further understand that the Oxnard Union High School District (OUHSD) has taken precautions to block inappropriate and/or controversial material through content filters. However, I recognize that it is impossible for the OUHSD to completely restrict access to inappropriate materials. I will not hold the OUHSD responsible for materials acquired through the Internet and/or related networks.

I understand that all OUHSD schools will include a Digital Literacy program at all grade levels so that every student will learn how to be safe, appropriate, and responsible online, both at home and at school. As the parent/guardian, I understand that I am responsible for supervising my child's use of technology, including the use of personal electronic devices and social networking, outside of the school setting.

It is the responsibility of the student, and his/her parent/guardian, to protect the security of any user names and passwords the student and/or parent uses. The OUHSD accepts no responsibility in the event a student and/or parent's/guardian's user name and/or password is shared, stolen, or in any other way becomes the possession of a person other that the student or parent.

Parents/guardians need to remember that email and other communications over the Internet are not guaranteed to be private and are subject to state and federal laws. Violations of the rules stated above may result in disciplinary action, including the loss of the student's privileges, suspension, and/or possible supervision and monitoring of a student's continued use of any devices involved in a violation of the AUP.

School and District authorized employees monitor the use of information technology resources to help ensure that technology resources are used securely and in conformity with this policy.

Administrators reserve the right to confiscate, examine, and disclose any information and/or data found on a student's device in order to further the health, safety, discipline, or security of any student or other person, or to protect property. They may also use this information in disciplinary actions and will furnish evidence of crime to law enforcement.

Attendance and Tardy Policy

Tardies

Students will be marked tardy based on the following:

Students are considered tardy when they are not in the proper class with all materials necessary for that class period at the time the class is scheduled to start.

Losing 30 minutes or more of instructional time is also considered a truancy if it does not fall within \underline{Ed} Code 48205.

More than 30 min Tardies

Students that come in tardy more than 30minutes must check in with Attendance Clerk first. Teachers must send these students to the office if they show up to class more than 30 minutes late and without a pass.

Tardy Protocol

- 3 tardies: Individual meeting with student and administrator
- 5 tardies- Parents will be notified of situation by Administration
- 8 Tardies Parent meeting will be held with Counselor, Administration, student and parents and Saturday School will be assigned.

Absences

Students will be marked absent if they are more than 30 minutes tardy.

Compulsory Education Law requires that students attend FULL days every day. Losing 30 minutes or more of instructional time is also considered a truancy if it does not fall within Ed Code 48205.

Protocolos de Asistencia

Tardanzas

Los estudiantes serán marcados tarde en base a lo siguiente:

Se considera que los estudiantes llegan tarde cuando no están en la clase adecuada con todos los materiales necesarios para ese período de clase en el momento en que la clase está programada para comenzar. Perder 30 minutos o más de tiempo de instrucción también se considera ausentismo escolar si no se encuentra dentro del Código de Educación 48205 .

Tardanzas de más de 30 minutos

Los estudiantes que lleguen tarde más de 30 minutos deben registrarse primero con la secretaria de asistencia. Los maestros deben enviar a estos estudiantes a la oficina si llegan a clase con más de 30 minutos de retraso y sin un pase.

Protocolo de Tardanzas

- 3 tardanzas: reunión individual con el estudiante y el administrador
- 5 tardanzas: la administración notificará a los padres sobre la situación
- 8 tardanzas: se llevará a cabo una reunión de padres con el consejero, la administración, el estudiante y los padresy Escuela de sábado será asignada.

Ausencias

Los estudiantes serán marcados como ausentes si tienen más de 30 minutos de retraso. La Ley de Educación Obligatoria requiere que los estudiantes asistan días COMPLETOS todos los días. Perder 30 minutos o más de tiempo de instrucción también se considera ausentismo escolar si no se encuentra dentro del Código de Educación 48205.

SCHOOL POLICIES/POLIZAS ESCOLARES

Closed Campus: Oxnard Middle College is a closed campus.

- Students are not permitted to leave without a pass, nor can anyone come on to campus without permission.
- Off campus during lunch time is not permitted
- Students wishing to go home from school due to illness must check out through the main office. Students will be allowed to leave only with adults listed on their current emergency card.

Campus cerrado: Oxnard Middle College es un campus cerrado.

- No se permite que los estudiantes salgan sin un pase, ni nadie puede entrar al campus sin permiso.
- No se permite salir del campus durante la hora del almuerzo.
- Los estudiantes que deseen irse a casa de la escuela debido a una enfermedad deben registrarse en la oficina principal. A los estudiantes se les permitirá salir solo con los adultos que figuran en su tarjeta de emergencia actual.

Health Services/Servicios de Salud

A doctor's prescription and parent consent are required for students to take any medication at school including inhalers. The required form is available in the main office and on our school's website. State law prevents students from carrying medication on campus; Students may be suspended for violations.

Se requiere una receta médica y el consentimiento de los padres para que los estudiantes tomen cualquier medicamento en la escuela, incluidos los inhaladores. El formulario requerido está disponible en la oficina principal y en el sitio web de nuestra escuela. La ley estatal impide que los estudiantes lleven medicamentos en el campus; Los estudiantes pueden ser suspendidos por violaciones.

Non Discrimination Policy/ Políza de no discriminación

It is important for everyone to understand that no person on this campus should be the subject of discrimination because of race, color, culture, religion, gender, ethnicity or disability. Any student or staff member who believes that anyone has subjected him/her to an act of discrimination should immediately report any such incident to a school counselor or administrator.

Weapons/Armas

No weapons, look alike weapons or dangerous objects are allowed on campus. Any weapon or dangerous object carried on campus will result on arrest and recommendation for expulsions. Random metal detector searches will be conducted.

Textbooks/Libros

In accordance with Williams Act, all students will be issued textbooks. Students who have lost or damaged textbooks and owe the school money will not be allowed to participate in any extracurricular activities until the debt has been resolved.

Student Confidencial Reports/Reportes Confidenciales de Estudiantes

Oxnard Middle College utilizes **WE TIP** as the platform for students to make confidential reports. Students can report any situations related to crime, misconduct, student safety including student self-harm. All reports are anonymous by calling or texting 844 8052580.

Students and parents can also make a report with the administration, Counselor or any adult employed by the school.

Oxnard Middle College utiliza WE TIP como plataforma para que los estudiantes hagan informes confidenciales. estudiantes pueden denunciar cualquier situación relacionada con delitos, mala conducta, seguridad de los estudiantes, incluidas las autolesiones de los estudiantes. Todos los informes son anónimos llamando o enviando un mensaje de texto al 844 8052580.

Los estudiantes y los padres también pueden hacer un informe con la administración, el consejero o cualquier adulto empleado por la escuela.

School-wide Dress Code Relating to Gang-Related Apparel (EC 35183)

The Governing Board believes that appropriate dress and grooming contribute to a productive learning environment. The Board expects students to wear clothing that is suitable for the school activities in which they participate. Students shall not wear clothing that presents a health or safety hazard or causes a substantial disruption to the educational program.

All students are expected to dress appropriately for a 9-12 grade educational environment. Any clothing that interferes with or disrupts the educational environment is unacceptable. Clothing with language or images that are vulgar, discriminatory, or obscene or clothing that promotes illegal or violent conduct, such as gang symbols, the unlawful use of weapons, drugs, alcohol, tobacco, or drug paraphernalia, or clothing that contains threats is prohibited. Clothing should conform to standards of safety and decency.

Procedures for Inappropriate Dress: Students in violation of the school dress code may be required to do one of the following:

- Cover the offending clothing with loaner clothes provided by the office.
- Contact a parent and have appropriate clothing brought to school.

NOTE: Repeated violations or a refusal to comply with dress code provisions will be considered defiance and may result in suspension.

Código de vestimenta de toda la escuela en relación con la ropa relacionada con pandillas (EC 35183)

La mesa directiva cree que la vestimenta y el arreglo personal apropiados contribuyen a un ambiente de aprendizaje productivo. La mesa directiva espera que los estudiantes usen ropa adecuada para las actividades escolares en las que participan. Los estudiantes no deben usar ropa que presente un peligro para la salud o la seguridad o que cause un daño sustancial o Interrupción del programa educativo.

Se espera que todos los estudiantes se vistan apropiadamente para un ambiente educativo de los grados 9-12. Cualquier ropa que interfiere o interrumpe el entorno educativo es inaceptable. Ropa con lenguaje o imágenes que sean vulgares, discriminatorias u obscenas o ropa que promueva conductas ilegales o violentas, tales como símbolos de pandillas, armas, drogas, alcohol, tabaco o parafernalia de drogas están prohibida incluyendo ropa que contenga amenazas. La ropa debe ajustarse a las normas de seguridad y decencia. Los padres o tutores de estudiantes que requieren adaptaciones por creencias religiosas, discapacidades u otras causas deben comunicarse con el director o su designado.

Procedimientos para Vestimenta Inapropiada: Los estudiantes que violen el código de vestimenta de la escuela deberán de seguir las siguientes normas:


- Cubrir la ropa infractora con ropa prestada por la oficina.







As an OMC student, I agree to all of the following expectations:

- Devote a minimum of **two hours** each evening to homework, studying, and reading.

- Maturely handle the freedoms and scheduling of a college setting, and understand that my existence on the college campus is a privilege, not a right.
- Comply with OMCHS rules and regulations.
- Maturely handle flexible scheduling and be able to make productive use of unscheduled time.
- I understand that OMCHS is a closed campus and that I will not leave campus at any time without prior approval and/or notification to the main office by a parent/guardian.
- Adhere to the Ed Plan and not add/drop or be dropped from any class without prior approval from the OMCHS counselor or administration.
- Keep parents informed of my academic progress at OMCHS.
- To be placed on probation and be obligated to attend mandated tutoring for the **semester** if quarter marks on **any** report card fall below a "C".
- Recognize and understand that OMCHS has no organized athletics. If I wish to engage in high school sports off campus, I may play for <u>my school of residence</u> with prior written approval from the principal and agree to maintain a GPA of 3.0. Students placed on academic probation will have their approval revoked.
- Understand that I may be referred to another OUHSD school if I do not:
 1) Maintain a 3.0 grade point average in high school classes and/or earn a mark lower than a "C" in a college class; and/or 2) Comply with OMCHS and OUHSD rules and regulations.
- OMCHS HAS A VERY STRICT DISCIPLINE POLICY, AS SUCH, STUDENTS CAN AND WILL BE SUSPENDED, EXPELLED, AND/OR DROPPED TO THEIR SCHOOL OF RESIDENCE. THIS INCLUDES A SINGLE VIOLATION.
