Notice is hereby given that on the 4<sup>th</sup> day of March, 2020, the Board of Trustees of the Nazareth Independent School District will hold an emergency meeting at 7:30 p.m., in the Nazareth ISD Cafeteria, 101 South First Street, Nazareth, Texas 79063. **An emergency or urgent public necessity exists that requires immediate action of the Board of Trustees, specifically, action concerning school procedures for opening in light of the continued COVID-19 outbreak, declared to be a world-wide pandemic by the World Health Organization and the subject of a Disaster Declaration by the Governor of the State of Texas.** The subjects to be discussed are listed on the agenda that is attached to and made a part of this Notice.

If, during the course of the meeting covered by this Notice, the Board of Trustees should determine that a closed or executive meeting or session of the Board of Trustees is required, then such closed or executive meeting or session as authorized by the Texas Open Meetings Act, Texas Government Code, Section 551.001 *et seq.*, will be held by the School Board at the date, hour, and place given in this Notice or as soon after the commencement of the meeting covered by this Notice as the School Board may conveniently meet in such closed or executive meeting or session concerning any and all purposes permitted by the Act including, but not limited to the following sections and purposes:
