

Notice of Special Meeting Nazareth Independent School District Board of Education August 5, 2019, 6:00 PM

Notice is hereby given that a regular meeting of the Nazareth Independent School District Board of Education will be held on the 5th of August, 2019 at 6:00 p.m. in the Nazareth ISD Board Room, 101 South First Street, Nazareth, Texas 79063. The subjects to be discussed or considered, or upon which any formal action may be taken, are as follows. If, during the course of the meeting, discussion of any item on the agenda should be held in closed meeting, the board will conduct a closed meeting in accordance with the Texas Open Meeting Act, Texas Govt. Code, Chapter 551, Subchapters D and E. Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in open meeting.

- 2. Interview candidates for the position of Superintendent of Schools
- 3. Discuss and take action as necessary to name a Lone Finalist for the position of Superintendent of Schools (Action Item)
- 4. Discuss and take action as necessary on matters related to district personnel including but not limited to performance, duties, assignment, salary and benefits (Action Item)
- 5. Student Insurance (Action Item)
- 6. Adjournment

If, during the course of the meeting, any discussion of any item on the agenda should be held in executive session, the Board will convene in such executive or closed session in accordance with the Open Meetings Act, Article 6252-17, Texas Civil Statutes. The Board will take no final action, make no decisions, nor cast any votes while in Executive Session. The presiding officer will reconvene the open meeting prior to formal adjournment.

Texas Government Code Section:

- 551.082 Considering discipline of a public school child, or complaint or charge against personnel.
- 551.0821 Deliberate a matter regarding student if personally identifiable information will be revealed.
- 551.083 Considering the standards, guidelines, terms, or conditions the board will follow, or will instruct its representatives to follow, in consultation with representatives of employee groups.
