Nazareth ISD BOE Regular Meeting August 10, 2022

The meeting was called to order by President Jenny Schulte at 7:33 p.m. Other members present were Vice President Alan Birkenfeld, Secretary Jennifer Heiman, Mac Annen, Mitchell Brockman, Marty Gerber, and Keith Hoelting. Also present was Superintendent Dr. Kara Sue Garlitz, Principal Rob O'Connor, and Assistant Principal Joli Johnson. The prayer was led by Mitchell, the pledge by Keith and the mission statement was read by Mac.

Steve Lapp was present to explain the insurance policy. A motion to approve the property, vehicle, cyber and liability insurance from Fairly Group/Public Educators Association of Texas and unemployment insurance through TASB was made by Mitchell and seconded by Alan. The motion carried 7-0.

For the Principal's Report, Mr. O'Connor introduced our new Assistant Principal Joli Johnson to the board. He then gave an update on the master schedule and explained how Meet the Teacher would work this year.

Superintendent Garlitz presented the Superintendent Report, which included the regular reports of District's current bills, financial reports, bank reconciliations, Castro CAD monthly tax collection, transportation report, facilities and operations. Approval of the check lists and financial reports will be considered under the Consent Agenda.

Cash flow and investments were presented. The pledged securities with Peoples Bank were reported and presented. Castro County Appraisal District reported that 99.30% of current M&O taxes and 99.29% of current I&S taxes have been collected. The certified tax values were presented.

Dr. Garlitz gave an update on facilities and operations, transportation, and personnel. Activity Account balances were presented. There are still a few outstanding purchase orders and some transfers that still need to take place.

Dr. Garlitz presented information on next year's budget in a workshop. The board will consider scheduling a special meeting on August 25 to adopt the budget and tax rate under the consent agenda.

Dr. Garlitz conducted the 2nd reading of the TASB Localized Policy Manual Update 119, which will be considered under the consent agenda. The staff in-service schedule was presented along with the preliminary School FIRST Rating, followed by upcoming board training opportunities.

A motion to approve the Consent Agenda including the July 13, 2022, regular meeting as corrected, financial reports, current check payment lists as presented, the approval of scheduling a

special meeting on August 24 for budget hearing and to adopt the tax rate, and the approval of TASB Localized Policy Manual Update 119 was made by Mac. The motion seconded by Marty, and motion carried 7-0.

Alan made a motion to approve Dr. Garlitz's recommendation for a district permit under the DOI Plan for Nicole Schulte to teach Art I, and Fine Arts/Music. The motion was seconded by Mitchell, and the motion carried 7-0.

Marty made a motion to approve Dr. Garlitz's recommendation that the Castro County SSA bus and the Band Trailer be declared surplus and sold or disposed of properly. The motion was seconded by Mac and the motion carried 7-0.

Jennifer made a motion to endorse Cindy Spanel for the upcoming TASB Region 16 Director election. The motion was seconded by Marty. It passed 7-0.

Time was provided for closing comments or further questions.

Keith made a motion and Mac seconded it to adjourn. The motion passed unanimously.

The meeting adjourned at 9:41 p.m.
