Nazareth ISD BOE Regular Meeting April 13, 2022

The meeting was called to order by President Marty Gerber at 7:33 p.m. Other members present were Vice President Mac Annen, Secretary Jenny Schulte, Alan Birkenfeld, Jennifer Heiman, Keith Hoelting, and Mitchell Brockman. Also present was Principal Robert O'Connor and Superintendent Dr. Kara Sue Garlitz. The prayer was led by Mac, the pledge by Keith and the mission statement was read by Mitchell. Guests included Cole Pierce with Castro CAD, Fred Stormer with Underwood Law and their financial consultant Lance Terrell.

Mr. O'Connor presented the Nazareth School Recognition which was the UIL Academic Program led by Cindy Huseman. Representing the program were seniors Trent Gerber, Tagan Ramsey, Brett Young, and Isamar Juarez. The Regional UIL Academics and Speech Meet will be Friday, April 22.

President Gerber opened the 2022 Wellness Plan Public Hearing and Information, at 7:40 p.m. The public hearing finished at 7:50 p.m. The Wellness Plan is available through the superintendent's office as well as on the district's website.

Cole Pierce from Castro CAD attended the meeting to answer questions from the board.

After a presentation from Fred Stormer and Lance Terrell, discussion, and questions concerning a Chapter 313 application for Castro Solar One, LLC, Mac made the following motion, "I move that the District hire the Underwood Law Firm, P.C. as special legal counsel to provide professional services relating to consideration of Applications for Appraised Value Limitation on Qualified Property, and to negotiate and draft any resulting Agreement for Limitation on Appraised Value on behalf of the District, and authorize the Board President to sign the engagement letter with the Underwood Law Firm to secure such services." The motion was seconded by Jennifer, and the motion carried 7-0.

Mitchell made the following motion, "I move that the Board: (1) accept for consideration Castro Solar One, LLC's Application for an Appraised Value Limitation on Qualified Property; (2) set a standard application fee of \$75,000 for such Application; and, (3) authorize the Superintendent to acknowledge receipt of the Application and application fee, review the Application and, upon a determination that such Application is complete, work with the Underwood Law Firm to submit the Application to the Comptroller as set out in Chapter 313 of the Texas Tax Code." The motion was seconded by Jenny, and the motion carried 7-0.

Under the Principal's Reports, Mr. O'Connor included enrollment/attendance information, a calendar of upcoming events, and an academic update.

Dr. Garlitz presented the Superintendent Report, which included the regular reports of District's current bills, financial reports, cash flow and investment report, Pledged Securities, Castro CAD monthly tax collection, facilities and operations, transportation, and personnel. It also included the 2022-2023 Salary Schedules, the 2022-2023 Transfer Students, extracurricular activity and adjunct faculty, Teacher Appreciation, Bayer Grant for STEM, Technology, TASB Risk Fund ILA, a COVID-19 update, the Instructional Material Allotment & TEKS Certifications for 2021-2022, and upcoming training opportunities.

Approval of the check lists and financial reports will be considered under the Consent Agenda. Cash flow and investments were presented. The pledged securities with Peoples Bank were reported and presented. Castro County Appraisal District reported that 97.04% of current M&O taxes and 97.06% of current I&S taxes have been collected.

Dr. Garlitz gave an update on facilities and operation, transportation, and personnel. The list of transfer applications for 2022-2023 were presented. Hereford 4-H has asked for consideration as an extracurricular activity and adjunct faculty status.

Nazareth ISD was nominated and selected to receive a \$5000 grant from Bayer, formerly Monsanto, for STEM. Under the Consent Agenda the board will consider approval of the purchase of Chromebooks, an updated ILA for TASB Risk Fund, and the Instructional Material Allotment & TEKS Certification for 2022-2023.

A motion to approve the Consent Agenda including the March 9, 2022 regular meeting minutes, financial reports, current check payment lists, approving a quote from Golden Light Equipment for the purchase of a cafeteria line, approving the 2022-2023 salary schedules, approving Hereford 4-H as an extracurricular activity and adjunct faculty, approving the quote for CDI for the purchase of Chromebooks, approving the TASB Risk Fund Interlocal Participation Agreement, and approving the Instructional Material Allotment and TEKS Certification for 2022-2023 was made by Keith. The motion was seconded by Mac, and the motion carried 7-0.

The board entered into closed session at 9:06 pm under section 551.074 in accordance with the Texas Open Meeting Act. The board exited closed session at 9:28 pm

Alan made a motion to approve Dr. Garlitz's recommendation to extend Mrs. Joli Johnson an 11-month probationary assistant principal contract for 2022-2023. The motion was seconded by Jennifer, and the motion carried 7-0.

Mitchell made a motion to approve Dr. Garlitz's recommendation to hire Taryn Keeter and Andrea Snead as teachers with probationary professional contracts for 2022-2023. The motion was seconded by Alan. The motion carried 7-0.

Mac made a motion to approve Dr. Garlitz's recommendation to renew the contracts of the teachers and counselor as presented. The motion was seconded by Jenny and the motion carried 7-0.

Time was provided for closing comments or further questions. Keith made a motion and Mac seconded it to adjourn. The motion passed unanimously. The meeting adjourned at 10:21 p.m.
