

**GATEWAY REGIONAL SCHOOL DISTRICT  
NON UNION LETTER OF EMPLOYMENT**

THIS AGREEMENT, is by and between the Gateway Regional School District and Wojcik, Speech and Language Pathologist Assistant (hereinafter referred to as "SLPA") agree to this Letter of Employment. The effective date of this agreement is the date of the last signed hereto this agreement below.

This agreement will continue in full force and effect until a successor is executed by the School District and the SLPA.

In consideration of the promises herein contained, the parties hereto mutually agree as follows:

1. **EMPLOYMENT:** The Committee hereby employs Kathleen Wojcik, Speech and Language Pathologist Assistant, and she hereby accepts employment on the following terms and conditions:
2. **TERM:** The SLPA shall be employed commencing August 28, 2023 and terminating on June 30, 2026.
3. **COMPENSATION:** The SLPA shall be paid an annual salary of \$42,000 Payable in equal installments convenient to the parties, but not less often than once every two weeks. The annual salary will be \$43,050 effective July 1, 2024 and \$44,126 effective July 1, 2025. Service hours will be 6.5 hours per day for a total of 182 days.
4. **TERMINATION:** In the event that the SLPA desires to terminate this contract before the term of services shall have expired, they may do so by giving at least a 60-day notice of their intention to the Superintendent. The Superintendent shall give at least a 60-day notice of its intention not to renew this contract.

This Agreement may be terminated at any time prior to the expiration date of the Agreement for good cause and/or for financial exigencies. In the case of financial exigencies, the Superintendent may terminate the Agreement, cause a reduction of the workday or work year, or demote the administrator to a less skilled position. If the workday or work year is reduced, there will be a corresponding proration of the salary to reflect the changed workday or work year.

5. **DUTIES:** The SLPA shall perform faithfully, to the best of their ability, their professional responsibilities, and other duties as may be assigned from time to time by the Superintendent of Schools, Pupil Services Director or by direction of the School Committee. Attendance at PD will be required if content is related to professional expectations. This will be determined by the Pupil Services Director. The SLPA will be provided with a SLP to supervise 20% of caseload as required of SLPA's credentialing. The SLP will perform the job responsibilities to the best of their abilities with the time the SLP can allocate to the position and prioritize duties in collaboration with the Pupil Service Director for all students, services, and locations at Gateway.


Direct contact with students including providing services and conducting assessments will be included in working hours. Attendance in meetings and completing reports will also be included in working hours.

6. CERTIFICATION: The SLPA shall furnish and maintain throughout the term of this contract a valid and appropriate certificate qualifying her to act as the Speech and Language Pathologist Assistant in the Commonwealth, or a currently approved waiver.
  
7. BENEFITS: The SLPA will receive 15 sick days and 2 personal days annually Previous sick time will be rolled over to the new position. The Committee authorizes seventy percent (70%) of the Blue Cross/Blue Shield P.P.O. plan of the type presently available to Non-Union employees. The employer contribution to the H.M.O. Plan will be seventy-five (75%) with the employee contributing the remaining twenty-five (25%). The committee authorizes seventy-five (75%)of the term life insurance, death and dismemberment of the type presently available to Non-Union.
  
8. RELATIONSHIP BETWEEN SLPA AND DIRECTOR OF PUPIL SERVICES: The SLPA shall meet with the Director of Pupil Services at least once each year for the purpose of discussing with the Director of Pupil Service their job description and performance as well as the working relationship.

This Agreement shall be executed in two counterparts, each of which shall be deemed to be an original, and both of which taken together shall be deemed on and the same instrument.

IN WITNESS THEREOF, the parties have hereunto signed this Agreement and a duplicate thereof this 7<sup>th</sup> day of August in the year 2023.
