Abstract:

An encumbrance is an accounting procedure that sets aside available funds for commitments related to unperformed contracts for goods and services, to ensure the availability of funds when payment is requested. This report includes prior year appropriations that were expended in the 2009 fiscal year. An appropriation is an authorization granted by the legislative body to make expenditures and to incur obligations for specific purposes. An appropriation is usually limited in amount and in the time during which it may be expended.

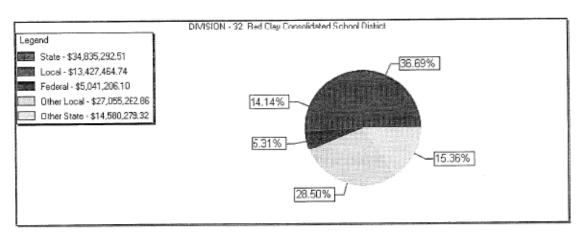

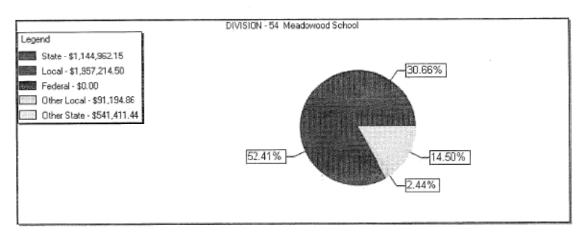

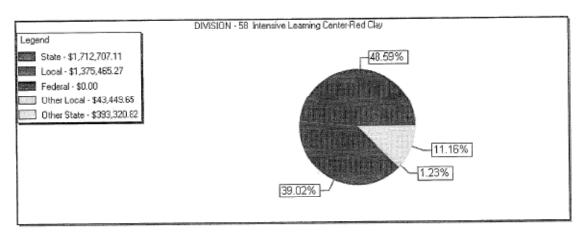
