The Business Office is responsible for the accuracy of the content found in the YTD Total Expenditures & Encumbrances Report. The CFRC reviews the document in order to track spending by the object code accounting system.

Abstract:

The YTD Total Expenditures and Encumbrances Report tracks district costs by object code and is used by the State of Delaware's accounting system to identify line item expenses and encumbrances. An encumbrance is an accounting procedure that sets aside available funds for commitments related to unperformed contracts for goods and services, to ensure the availability of funds when payment is requested. This report excludes prior year appropriations and most closely parallels the district's monthly financial report by Intermediate Budget Unit (IBU), which primarily focuses on expenditures by programs and departments.






