 - 2. Student Council President Lizette Diaz reported on HES activities including the Valentine's Dance, See's Candy fundraiser that earned \$4,000, missions display and presentations by 4th graders, Science projects, award incentives, and other fundraisers.

- 8.5 Technology Report by Allan Bradley. Director Bradley presented on the network

system, demonstrating how the new network allows teachers to bring more information into the classroom and how this new system will support about anything we decide to create within our district regarding technology.

8.6 Principal and Dean of Student Reports.

- 1. Cris Oseguera, Hamilton High School Principal, stated that the high school is developing a team concept and thanked the Board for rescinding some of the precautionary notices. He expressed his hope the remainder will be rescinded as well. He reported on the revised API and attendance rate as well as the upcoming Every 15 Minutes, Spring Concert, and Open House activities. FFA student Samantha Poldervaart presented her Dairy Industry speech, and Ms. Lohse reported on awards at regional meeting.
- 2. Darcy Pollak, Hamilton Elementary School Principal, reported on activities including online STAR testing pilot with 8th graders, April STAR testing, English Boot Camp, kindergarten registration, Long-term sub, Adam Stahler; 2013-14 scheduling that includes collaboration and intervention time, Common Core development, PLC focus (thanked the Board for supporting PLC participation), and bully prevention staff development by Kile Taylor.
- 3. Maria Reyes, District Dean of Students, reported on Cahsee testing and Alternative Education, which included field trips to Butte College, CSU, Chico, senior project, weekly attendance incentive, and upcoming STAR testing.

8.7 Superintendent Report by Charles Tracy.

- 1. Fiscal Services Report Update. The State's income increased in January only to decrease in February resulting in a net income of just over 5 billion to the positive. Encouraging and optimistic news that we need to keep our eye on and see what happens in May.
- 2. PLC Presentation. (moved to follow 11.2) The group that attended the February PLC conference reported to the Board how they feel the PLC philosophy will be implemented and expressed a positive experience and enthusiasm to "just start it." Participants included Janice Peterson, Trudy Bryan, Hogan Brown, Ryan Bentz, Maria Llamas, Erica Gorden, and Lynn Larson.
- 3. Board Member Participation at Promotion and Commencement Ceremonies was agreed upon. Hamilton Elementary: Judy Twede and Gabriel Leal; Hamilton High/EBHS: Wendall Lower and Tim Anderson.
