### 10.0 **COMMUNICATIONS/REPORTS**.

- 10.1 Board Member Comments/Reports. None.
- 10.2 ASB President and Student Council President Reports.
  - 1. Hamilton High ASB President Kristian Diaz reported on sports, fundraisers, and activities including FFA sales, MEChA Giving Tree, Band Concert, Band performance in Chico, and December 19 minimum day.
  - 2. Hamilton Elementary Student Council President Michaela Brantingham reported on sports and congratulated the Lady Wolves on their championship, the basketball clinic, Christmas Grams, Christmas program, Jingle Run, See's, canned food drive, and winter break.
- 10.3 District Reports (written reports submitted).
  - 1. Food Service Report by LeAnn Radtke included November SNP reports.
  - 2. Operations Report by Marc Eddy included Bus miles driven, and maintenance and repairs for November.
  - 3. Technology Report by Allan Bradley included a summary of his department's main objectives, which included the HHS portable and cafeteria work, writing the technology plan, email archiving, Community Day School VPN, student desktop updates, viruses and malware, Aeries Analytics, large screen TVs, and spam.
- 10.4 Principal and Dean of Student Reports.
  - 1. Cris Oseguera, Hamilton High School Principal, reported on the high school's strong attendance rate, December 19 minimum day and assembly/rally, semester discipline rates—commended students, parents, and teachers; finals, end of semester activities including December 15 Band Performance (invitations given to Board), and STAR testing. He introduced Katie Freitas, FFA Reporter, and she reported on Christmas Tree Sales including wreaths, mandarins, and olive oil. She noted that the olives were harvested by Conway Couto's and Adam Kennedy at no charge.
  - 2. Darcy Pollak, Hamilton Elementary School Principal submitted a written report in lieu of her absence. The following reports were made from her site.
    - Michael Brantingham gave a presentation on what's happening with some of his more advanced students in his Research and Technology classes. Students are very receptive and grades have increased since the beginning of the year.
    - o Kile Taylor spoke about the bullying prevention program, which just concluded a two year grant from Chico State that funded the program including staff development. The staff had exposure to over 20 hours of staff development over the two year period. They will now move into the family portion of the program. About a dozen families signed up to participate in some capacity. Mr. Tracy congratulated Mr. Taylor for his selection as the featured speaker at NW PBIS conference in Portland, Oregon in February to speak on bullying.
  - 3. Maria Reyes, District Dean of Students, reported on Alternative Education attendance, that all seniors have passed CAHSEE, the MEChA Giving Tree, and activities including Reg-to-Go at Butte College and Cash for College workshop.

  - 1. The Board Visitation Day will be held on February 4, 2013, tentatively 8 a.m. to 12 p.m.
  - 2. The Board Governance Training Day will be maintained as a bi-annual event.
  - 3. The Band will be performing in Chico with the Chico Community Band at the Lakeside Pavilion, 2 p.m. on Sunday, December 15.
