- 8.2 Student Body President Report. Isaac Martinez reported on student activities including English Enrichment Trip to see Mama Mía, Senior Project papers, FNL Conference, Lady Braves to 2nd round of State, Spring Sports, and May 5 Prom.
- 8.3 Principals and Dean of Students Reports.
 - 1. Mr. Cris Oseguera, Hamilton High Principal, reported on 97% attendance and perfect attendance incentive, Open House, professional development, student activities and sports.
 - 2. Cody McCorkle and Hank Henning presented the annual FFA report. A handout was distributed and reviewed about Ag classes, career development events and contests, community service, and Glenn County Fair Livestock Exhibitors.
 - 3. Mr. Tracy expressed his appreciation to Ms. Lohse and Mr. Bentz for their efforts at the Regional meeting and the fine job they did.
 - 4. Ms. Maria Diaz, Hamilton Elementary Principal, distributed and reviewed a handout of staff and student activities as well as the increase in CELDT scores. An excellent video on bullying was presented, which was comprised of comments from Hamilton Elementary students and staff.
 - 5. Ms. Maria Reyes, Ella Barkley High Dean of Students, reported on Cahsee testing last week, career opportunity field trips, attendance, and issued an invitation to the Board to visit them on April 5 when they'll be baking bread.
- 8.4 Superintendent Report by Charles Tracy.
 - 1. April 5 Board Visitation Day schedule and Open House flyer reviewed.
 - 2. Hamilton High School Diplomas presented for Board President's signature.
 - 3. Board Member Participation at Promotion and Commencement Ceremonies.
 - a) HHS: Gabe Leal, Tomas Loera
 - b) HES: Tim Anderson, Judy Twede (Bill Boone, alternate)
 - 4. Implementation of Assembly Bill 1330. Career Technical Education course option in lieu of Visual or performing arts or foreign language graduation requirements. No guidance posted on the CDE website about how to proceed or deal with graduation requirements. Mr. Langan will be asked to do additional research and the Board will need to adopt as part of graduation requirements.
 - 5. CALPADS Spring 1 Submission. Update to Board about the importance of EL reporting and its effect on EIA and Title III funding. The District could be put in jeopardy with title III program improvement if not accurate.
 - 6. Students with Disabilities and the California High School Exit Examination Update. In 2012-13, a student is entitled to a standard diploma or certificate of completion if he/she meets IEP, has taken all CAHSEE exams, and meets district graduation requirements as indicated in IEP.
 - 7. State Schools Chief Tom Torlakson Responds to Federal Report on Student Suspension and Expulsion Rates. It is incumbent upon every district to insure it has a means of intervention before resorting to suspension and expulsion. Mr. Tracy believes our District has a plan in place that meets all the requirements of state and federal law.

- 9. Communication: Letter from Senator Barbara Boxer congratulating Ms. Erin Moore on team's participation in Academic Decathlon. Mr. Tracy thanked Ms. Moore and high school teachers for their support.

9.0 **DISCUSSION ITEMS**

- 9.1 Resolution for District bond.
 - 1. In support of the bond, Leigh McDaniel, Board of Supervisors Member, reported on the county's plans for Hamilton City, including (1) the Hamilton City Task Force that has been launched to focus on the needs of the community for future safety, youth events, senior events, improving parks, etc. with the new roller hockey rink as the flag ship; (2) emphasis on general public clean-up of highway 32 and Walsh Avenue; (3) grant opportunities; and (4) the Hamilton City Chamber of Commerce effort.
 - 2. Mr. Tracy reviewed some specifics of the resolution, which is similar to last time and there was a question and answer period.

 - 2. Exclusive use was discussed verses priority usage. Ms. Twede requested additional information on costs, insurance, and liability issue. Item to be tabled until April meeting.
- 9.4 Bill Boone was recommended by the District as the Glenn County Hall of Fame award recipient for 2012.
- 9.5 Diane Lyon gave an overview of the Second Interim report. She extended an invitation to board members to call her any time for clarification and additional information.
- 9.6 The investigation and discussion regarding reopening Hamilton Elementary Community Day School will continue into the April or May meeting.
