 - 1. Food Service Report by LeAnn Radtke. Ms. Radtke updated the Board on meals served in December and January, staff development for her and the high school Cook, and the need to increase the price of meals. Leslie Anderson expressed her appreciation for Ms. Radtke and thanked her for her efforts preparing lunches for parents; she is doing a nice job. Mr. Tracy reported to the Board how LeAnn is preparing the food for District meetings and thanked her for a job well done. Darcy Pollak, Hamilton Elementary School Principal updated the Board on a successful Saturday School, new evacuation plan, fire drill procedures, lockdown procedures, DAC meeting on Monday and staff presentation, staff development, summer school, Smarter Balanced testing preparation, and the elementary Golf Tourney.
 - o Leslie Anderson, Teacher on Special Assignment, reviewed a handout with the Board on Assessment/Common Core State Standards (CCSS) Overview. Ms. Anderson reported on the transition in testing, from STAR to CAASPP (California Assessment of Student Performance and Progress). The Common Core State Standards for ELA and mathematics have been adopted with the purpose of preparing students for college and career. California is a part of the Smarter Balanced Assessment Consortium (SBAC). Reviewed test problem examples and HUSD next steps. Mr. Lower stated that regardless of the transition in testing, the Board will still need to see evidence of improvement from the elementary school.
